It's unfortunate this matter has come to light or was even proposed during the COVID-19 pandemic, as it impairs the community's ability to respond as it normally would. I am among those at risk, which severely limits my ability to interact with others outside the trust group.

After reviewing the planning documents and viewing satellite imagery of the site via Google maps, I am opposed to the development.

Carlo Car Wash if allowed to proceed will compromise the privacy and quality of life of the remaining residents on and near that block. The existing businesses on that block are low traffic and have been relatively non-intrusive. The new development will be high traffic, noisy, and very disruptive.

Carlo Car Wash will increase traffic near a school, a Church, a community theater, and on Union Blvd near my property. It is already difficult to get onto Union from side streets with the heavy traffic it now carries under normal circumstances.

I also oppose the removal of existing homes. Such properties and vacant parcels should, as necessary, be renovated or redeveloped for residences.

This area is a long standing safe residential neighborhood that needs to be preserved as such.

Thanks for your time on the phone earlier this week to discuss the above project. My comments are as follows:

- Consideration should be given to screening the drive aisles at either end of the car wash building to prevent nuisance headlight glare to pedestrians and traffic on North Union Boulevard. This could become critical given the proposed grading with respect to the existing grades in the ROW. I assume buffer screening for adjacent properties and different zones is part of the zoning code/development standards.
- Consideration should also be given to mitigating noise from car wash operations such as drying fans, vacuums, etc.
- A statement of operational hours might be beneficial for homeowners and proprietors immediately adjacent. I understand through our discussions that those hours cannot be practically enforced, but the neighbors probably have a right to know and object to any hours of operation that could be deemed excessive or undesirable.
