He then transferred to detective positions in the Crimes Against Children Unit (2007-2010) and Homicide Unit (2010-2013). He was promoted to Sergeant in 2013, serving as a Patrol Supervisor (2013-2014), Detective Sergeant in the Special Victims Section (2014-2017) and Internal Affairs sergeant (2018). He was promoted to Lieutenant in 2018, serving in the Sand Creek Division (2018-2019) and the Strategic Information Center in Metro VNI (2019-2020). He was promoted to Commander in 2020 and has served in the Gold Hill Division (2020-2022), the Professional Standards Division (2022-2023) and the Management Services Division (2023-2025). He was promoted to Deputy Chief in March of 2025 and assigned oversight of the Investigative and Specialized Operations Bureau.

Deputy Chief John Koch holds a Bachelor of Science degree in Computer Information Systems from the University of Northern Colorado and a Master's of Public Administration from the University of Colorado.

Deputy Chief John Koch is a LEADS scholar with the United States Department of Justice & International Association of Chiefs of Police and he is a graduate of the FBI National Academy - Session 286.
