

ORDINANCE NO. 15-38

AN ORDINANCE AMENDING ORDINANCE NO. 14-101 (2015 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE FOLLOWING FEDERAL ENTITLEMENT GRANTS: COMMUNITY DEVELOPMENT BLOCK GRANT (INCREASE BY \$22,268), EMERGENCY SOLUTIONS GRANT (INCREASE BY \$58,195), AND HOME INVESTMENT PARTNERSHIPS GRANT (INCREASE BY \$173,094)

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 14-101 is hereby amended by increasing the the Community Development Block Grant (CDBG) expenditure appropriation in the amount of \$ 22,268. The source of funds is the Department of Housing and Urban Development's CDBG program.

Section 2. That Ordinance No. 14-101 is hereby amended by increasing the Emergency Solutions Grant (ESG) expenditure appropriation in the amount of \$58,195. The source of funds is the Department of Housing and Urban Development's ESG program.


Section 3. That Ordinance No. 14-101 is hereby amended by increasing the Home Investment Partnerships Grant (HOME) expenditure appropriation in the amount of \$173,094. The source of funds is the Department of Housing and Urban Development's HOME program.

Section 4. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.




