

ORDINANCE NO. 16-51

AN ORDINANCE AMENDING ORDINANCE NO. 15-86
(2016 APPROPRIATION ORDINANCE) FOR A
SUPPLEMENTAL APPROPRIATION TO THE PIKES PEAK
– AMERICA’S MOUNTAIN FUND IN THE AMOUNT OF
\$150,000 FOR THE PIKES PEAK SUMMIT COMPLEX
PROJECT

WHEREAS, the City’s original 2016 Budget for the Lodgers and Automobile Rental Tax (LART) Fund included \$100,000 of support for the Pikes Peak – America’s Mountain Summit Complex Project; and

WHEREAS, the cancellation of the Pro-Cycling event in 2016 has made additional LART funds available, and the LART committee has agreed to increase the Pikes Peak - America’s Mountain’s award notification in the amount of \$150,000.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:


Section 1. That Ordinance No. 15-86 is hereby amended by increasing the revenue and expenditure appropriations of the Pikes Peak – America’s Mountain Fund in the amount of \$150,000 for the Pikes Peak Summit Complex Project. The source of funds is a transfer from the LART Fund.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.



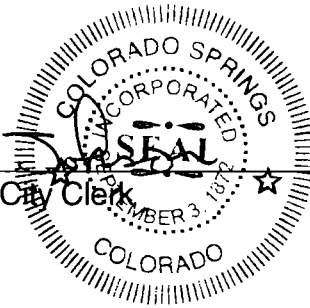
