A ORDINANCE AMENDING ORDINANCE NO. 16-116 (2017 APPROPIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE PUBLIC SPACE AND DEVELOPMENT FUND IN THE AMOUNT OF \$60,000.00 TO FUND THE PLANNING PROCESS FOR THE LARRY OCHS SPORTS COMPLEX

WHEREAS, each year the Parks, Recreation and Cultural Services Department conducts a public process to assist in establishing priorities for the annual Capital Improvement Program (CIP) budget. On June 9, 2016, the Parks and Recreation Advisory Board reviewed and recommended the Parks CIP Budget for inclusion in the City's CIP Budget; and

WHEREAS, the Larry Ochs Sports Complex is an undeveloped 57.82 acre sports complex within the Briargate Master Plan"; and

WHEREAS, the Parks Department has engaged Interquest Westside LLC, the property owner of Colorado Crossing, in a land exchange to relocate the existing Larry Ochs Sports Complex to a portion of Colorado Crossings; and

WHEREAS, with the relocation of the Larry Ochs Sports Complex to Colorado Crossing, Interquest Westside LLC, will develop the existing Larry Ochs Sports Complex site for residential units; and

WHEREAS, the existing Larry Ochs Sports Complex will need to be rezoned to a PUD zone before the closing of the properties can occur; and

WHEREAS, City Parks, Recreation & Cultural Services requests the approval of City Council to approve a supplemental appropriation to assist with studies (i.e. traffic and drainage) needed to satisfy the Planning Departments requirements for a rezone of the Larry Ochs Sports Complex in the amount of \$60,000.00

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 16-116 is hereby amended by increasing the Public Space and Development fund expenditure appropriation in the amount of \$60,000, which will provide funding to complete the planning process for the Larry Ochs Sports Complex. The source of funds is the available fund balance in the PLDO fund.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance by available for inspection and acquisition in the office of the City Clerk.
