Citizen Dustin Homan spoke about issues with I-25 on-ramps.

Citizens Melody Griffin, Vickie Parris, Peter Franz, Jim Hocking, Bob Jack, Mike Anderson, and Ralph Everett from Save Our Streets Nevada requested safety-sizing Nevada Avenue in the Old North End neighborhood. Councilmember Strand asked if they are requesting safety-sizing all four streets in the Old North End neighborhood. Mr. Anderson confirmed they were.

Commander Sean Mandel, Colorado Springs Police Department (CSPD), presented the amendment to the Ordinance, pertaining to the authority to impound recreational vehicles and providing penalties for vehicles parked

for extended periods of time in any public right of way. He said the proposed amendment eliminates the language “in a residential area” to include all public right of ways.

Councilmember Murray asked if there is list of locations these people can move to. Commander Mandel stated the Homeless Outreach Team (HOT) team will advise them of resources where they can receive assistance.

Citizen Douglas Sharp, Reverend Ann Steiner Lantz, Scott Anderson, Alicia Erickson, Reverend Jackie Franklin, Victoria Heim, Glen Pressman, Reverend Daniel Smith, John Shephard, and Pastor Paula Stecker spoke in opposition of the proposed Ordinance.

Citizen Scott Wiser asked how this will affect tourists parked while they go into a restaurant. Commander Mandel stated tourists parked for a short periods of time will not be a problem.

Citizen Gerald Miller spoke in favor of the proposed Ordinance.

Councilmember Murray asked how many RVs would be affected. Commander Mandel stated he does not have an exact number, but they receive a large number of complaints from business owners and consumers.

President Pro Tem Gaebler stated additional work needs to be done to address this issue and there needs to be a more robust public process.

Jeff Greene, Chief of Staff, stated there is already an existing Ordinance in place to protect residential owner private property rights and there needs to be equality with the rights of commercial businesses and retail areas.

Councilmember Geislinger stated the City needs to address public health and safety issues, but agrees that more work needs to be done to provide assistance to these individuals. He requested the item be postponed until the March 26, 2019 City Council meeting.

Councilmember Knight stated he does not support postponing it because there continues to be safety issues with black water being dumped into the stormwater drains and there needs to be a sense of urgency regarding this issue.

Councilmember Strand stated this Ordinance is based on health and safety issues and he also does not support a delay.

Councilmember Pico stated this will help enforce against polluting in public areas.

Councilmember Murray stated there needs to be a solution for where these RVs are able to park.

Councilmember Bennett stated this issue has caused a huge impact on the business community and it should not be delayed.

Councilmember Avila stated she does not support this Ordinance because she believes it would be immoral to impound someone's home and belongings. She stated the homeless are targeted for health and safety issues even though there are many other causes of pollution.

Councilmember Knight stated the Ordinance gives Colorado Springs Police Department (CSPD) the tools to inform individuals where they need to move to. He said it is not the intent that all the RVs will be impounded.

Mr. Greene said the CSPD are not currently able to address the calls they receive regarding these issues.

Councilmember Geislinger stated postponing the item for two months will not be detrimental.

President Skorman stated there needs to be a place for these people to go and he supports postponing it.

Councilmember Pico stated he believes it is a mistake to postpone it and the areas that have been suggested for these RV's to move to are privately owned.

Councilmember Knight asked if the Ordinance could be passed with an effective date of April 1, 2019. Councilmember Geislinger and President Skorman stated they will vote for this Ordinance on March 26, 2019, but want time to investigate a possible solution.

President Skorman stated he may request a reconsideration prior to March 26, 2019 if nothing substantial comes forward quickly.

Councilmember Knight commented that Council rules would have to be suspended if the reconsideration is not made prior to noon on January 11, 2019.
