ORDINANCE NO. 14-

AN ORDINANCE AMENDING SECTION 218 (SIGNAL LAMPS AND DEVICES; STREET ROD VEHICLES AND CUSTOM MOTOR VEHICLES) OF PART 2 (VEHICLE EQUIPMENT AND INSPECTION) OF ARTICLE 22 (VEHICLE EQUIPMENT AND INSPECTION); SECTION 101 (OBSTRUCTION OF VIEW OR DRIVING MECHANISM) OF ARTICLE 23 (MISCELLANEOUS RULES OF THE ROAD); AND SECTION 101 (COMPULSORY VEHICLE INSURANCE) OF ARTICLE 28 (COMPULSORY INSURANCE) OF CHAPTER 10 (MOTOR VEHICLES AND TRAFFIC) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO MOTOR VEHICLES AND TRAFFIC

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 218 (Signal Lamps and Devices; Street Rod Vehicles and Custom Motor Vehicles) of Part 2 (Vehicle Equipment and Inspection) of Article 22 (Vehicle Equipment and Inspection) of Chapter 10 (Motor Vehicles and Traffic) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

10.22.218: SIGNAL LAMPS AND DEVICES; STREET ROD VEHICLES AND CUSTOM MOTOR VEHICLES:

A street rod or other custom vehicle may display a blue dot taillight as authorized in Colorado Revised Statutes section 42-4-215.5 **42-12-204**.

Section 2. Section 101 (Obstruction of View or Driving Mechanism) of Article 23 (Miscellaneous Rules of the Road) of Chapter 10 (Motor Vehicles and Traffic) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

10.23.101: OBSTRUCTION OF VIEW OR DRIVING MECHANISM:

* * *

C. No person shall drive any motor vehicle equipped with any television viewer, screen or other means of visually receiving a television broadcast which is located in the motor vehicle at any point forward of the back of the driver's seat, or which is a video display visible to the driver while operating the motor vehicle is in motion. This subsection (C) does not prohibit the usage of a computer, data terminal, or safety equipment in a motor vehicle so long as the computer, data terminal, or safety equipment is not used to display visual entertainment, including internet browsing, social media, and e-mail, to the driver while the motor vehicle is in motion.

10.28.101: COMPULSORY VEHICLE INSURANCE:

* * *

F. Affirmation Of Insurance: Upon receipt, the owner of a motor vehicle shall sign and date an affirmation of insurance in the space provided on a vehicle registration described in title 42, article 3 of the Colorado Revised Statutes.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
