

ORDINANCE NO. 17-112

AN ORDINANCE REPEALING ORDINANCE NO. 17-11
(APPROVING THE SALARY OF THE CITY AUDITOR) AND
PRESCRIBING THE SALARY OF THE CITY AUDITOR

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
COLORADO SPRINGS:

Section 1. In accordance with City Charter § 3-10(e) and City Code § 1.2.203, the annual salary of the City Auditor, commencing retroactively to January 1, 2018, shall thereafter and until and unless amended by Council be set at \$151,920.67.

Section 2. This ordinance supersedes all prior ordinances setting the salary of the City Auditor that are inconsistent herewith, and shall remain in effect until superseded by ordinance.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
