

ORDINANCE NO. 17-65

AN ORDINANCE AMENDING ORDINANCE NO. 16-116 (2017 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS (TOPS) FUND (OPEN SPACE CATEGORY) IN THE AMOUNT OF \$580,000 FOR THE ACQUISITION OF APPROXIMATELY 85.61 ACRES OF REAL PROPERTY KNOWN AS THE KYLE PROPERTY FOR EXPANSION OF CORRAL BLUFFS OPEN SPACE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 16-116 is hereby amended by increasing the expenditure appropriations to the Trails, Open Space and Parks (TOPS) Fund (Open Space Category) in the amount of \$580,000 for the acquisition of approximately 85.61 acres of real property known as the Kyle Property, which amount includes acquisition-associated costs, for expansion of the Corral Bluffs Open Space. The source of funds is the TOPS Fund available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
