

RESOLUTION NO. 64-15

A RESOLUTION DESIGNATING THE MONTH OF JUNE TO BE BIKE MONTH IN THE CITY OF COLORADO SPRINGS

WHEREAS, bicycling is a viable, efficient and environmentally sound mode of transportation, as well as a popular form of recreation that plays an important part in the lives of many Colorado Springs residents and visitors by providing a means to travel to work, school, parks and other destinations across our community; and

WHEREAS, the City of Colorado Springs has over 150 miles of off-street bike paths, 140 miles of mountain bike trails, 110 miles of on-street bike lanes, one soon-to-be enclosed velodrome, two BMX parks and cyclist access to the 14,115' summit of Pikes Peak-America's Mountain; and

WHEREAS, the League of American Cyclists has designated Colorado Springs as a "Bicycle Friendly City" at the Silver Level in recognition of the City's strong cycling culture and expanding bicycle infrastructure network; and

WHEREAS, nation-wide 12 of the 15 fastest growing cities, 7 of the top 10 cities by educational attainment, and 13 of the 15 most popular cities for millennials were recognized as "Bicycle Friendly Cities" by League of American Cyclists ; and

WHEREAS, annually 80,000 cyclists visit and stay overnight in Colorado Springs; the local cycling industry employs more than 370 residents; and, the direct economic impact of cycling in our region is over \$27,850,000 each year; and

WHEREAS, the City of Colorado Springs joined the Healthy Eating and Active Living (HEAL) Towns and Cities Campaign in 2014 recognizing the importance of supporting opportunities for physical activity; and

WHEREAS, creating bicycle-friendly communities has been shown to improve citizens' health, well-being, and quality of life, to boost community spirit, to improve traffic safety, and to reduce pollution and congestion; and

WHEREAS, the Pikes Peak Area Council of Governments is completing a Regional Non-Motorized Transportation Plan and the City has initiated an update of the Bicycle Master Plan that will support continued development and improvement of cycling infrastructure across Colorado Springs; and

WHEREAS, June has been declared 'Bike Month' in the State of Colorado and June 24 is Colorado Springs Bike to Work Day; and


WHEREAS, declaring June 'Bike Month in Colorado Springs' will raise
