Councilmember Bennett recused himself due to his son, daughter-in-law, and wife own and/or manage a short term rental unit in the City.

Meggan Herington, Assistant Planning Director, gave a brief summary of the proposed changes regarding the annual permit and guidelines for establishing standards for short term rental units.

Councilmember Strand asked if there was a timeframe for when the owner or property manager must respond to a reported issue. Ms. Herington stated they must respond within an hour.

Councilmember Strand requested the Ordinance be revisited in June or July 2019. Peter Wysocki, Director of Planning and Community Development, stated they will be able to present the acquired data at that time, but a revised Ordinance would require additional time.

Citizens Michael Applegate, Marie McGinnis, and Patty Krough, representing the Neighborhood Preservation Alliance, requested amendments to the Ordinance to include short term rental units be limited to owner-occupied, a cap placed on the growth of the industry, data is collected from the platforms by a third party software company, and stated this Ordinance conflicts with current City Code.

Citizen Cathy Crawley stated these houses do not meet the requirements of the fire safety self-inspection checklist.

Councilmember Avila stated she does not support this Ordinance because she does not believe it is ready and there should be an owner-occupied requirement.

Councilmember Geislinger asked about if there has been any progress made regarding a third party verification process to ensure owners of short term rental units have obtained a permit. Mr. Wysocki stated he will provide that information.

Councilmember Knight stated he will be voting for this Ordinance and requested the data be reported to Council monthly.

Councilmember Murray stated this Ordinance will assist in providing the City the information that it currently does not have.
