Subject Title: City Council Appointments and Reappointments to Boards, Commissions, and Committees

City of Colorado Springs Public Facilities Authority

The City of Colorado Springs Public Facilities Authority operates under a structure that comprises five Directors. Among these, two members of the City Council are appointed by a majority vote of the council via resolution. Additionally, one member, representing the Mayor's office, is appointed by the Mayor. The remaining two positions are held ex officio by the Mayor or their designee, and the Chief Financial Officer. Appointed City Council members serve four-year terms, subject to removal by the City Council for good cause. Should a vacancy occur, the City Council will appoint a member to serve the remainder of the term.
