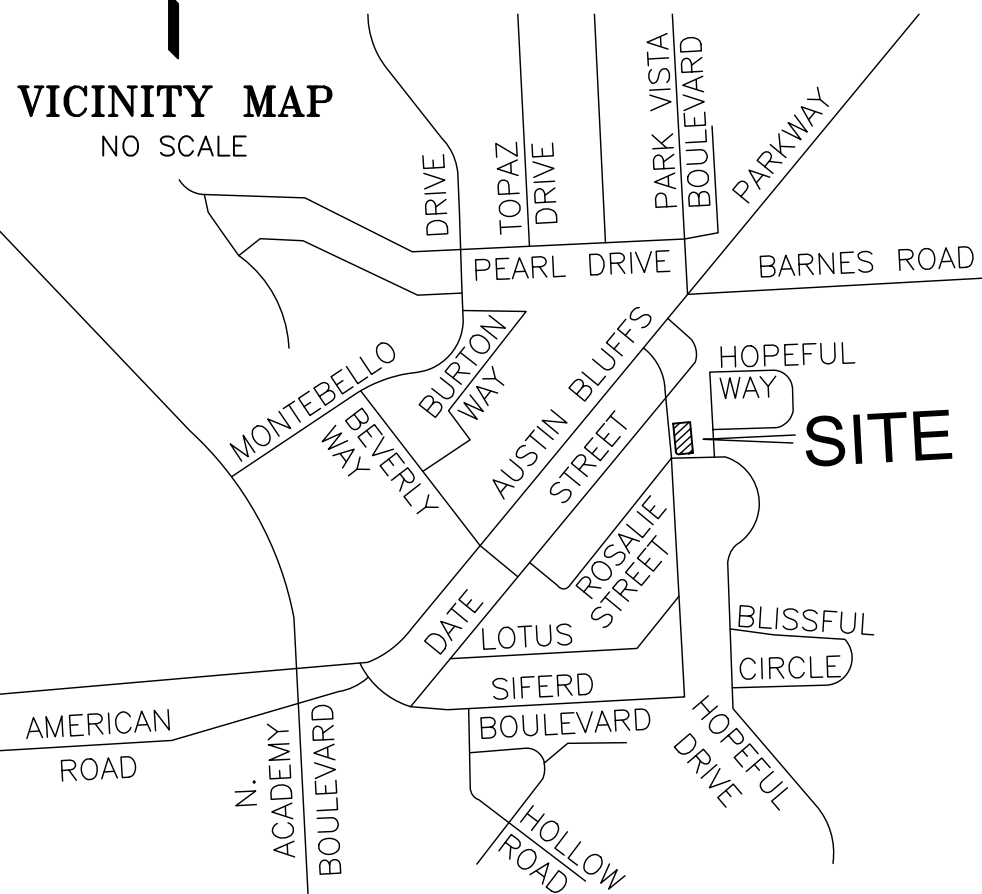


ANNEXATION PLAT - EXTOL PARK VISTA ADDITION NO. 2

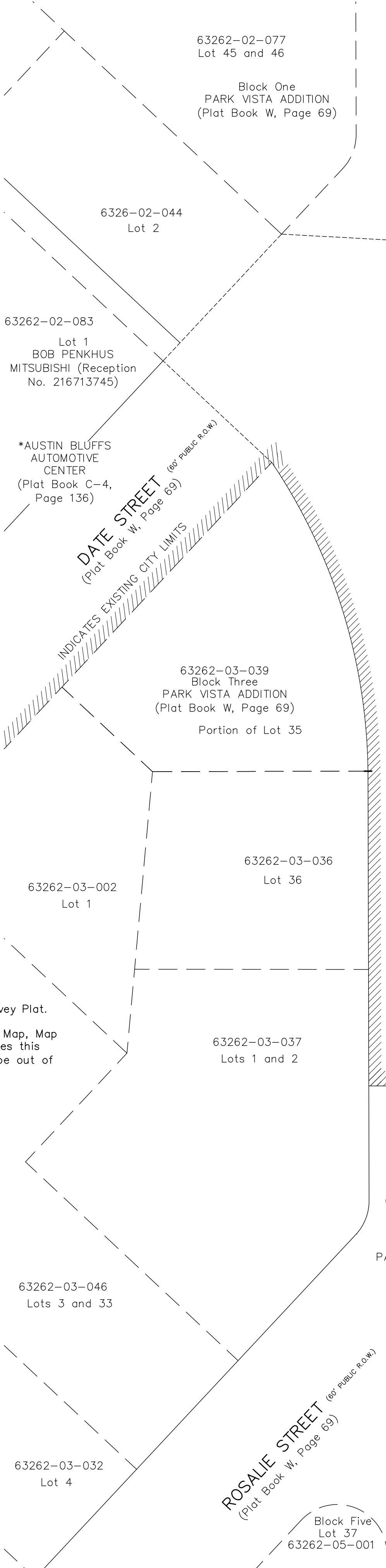
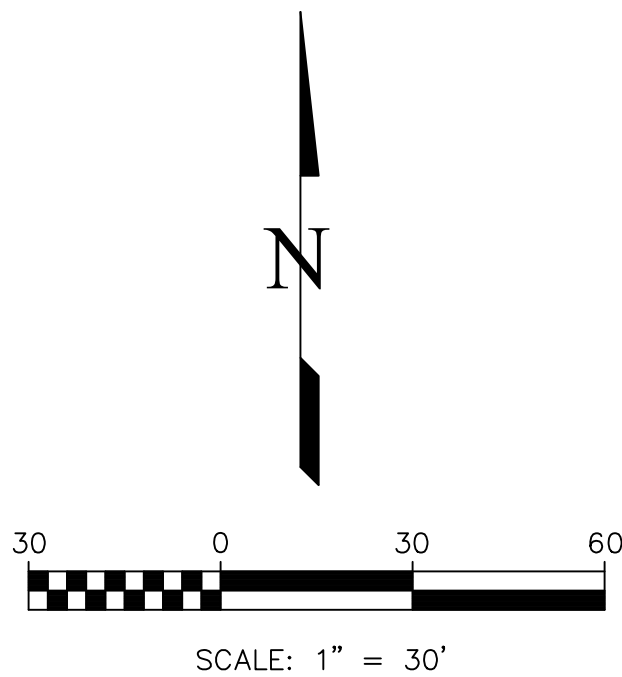

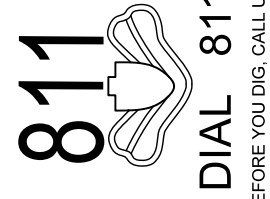
