

RESOLUTION NO. 87-20

**A RESOLUTION RESCINDING RESOLUTION 18-11 AND  
ESTABLISHING LICENSING FEES FOR CATS AND DOGS  
AND REDEMPTION FEES FOR IMPOUNDED ANIMALS**

WHEREAS, on January 25, 2011, City Council adopted Resolution 18-11 establishing Licensing Fees for Cats and Dogs; and

WHEREAS, the City of Colorado Springs recognizes the important of animal control services within the City and the increasing cost of providing such services; and

WHEREAS, this resolution rescinds Resolution 18-11 and supersedes any other related resolution pertaining to the fees outlined below; and

WHEREAS, this resolution establishes the new licensing fees for cats and dogs and redemption fees for impounded animals.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:**

Section 1. That the City of Colorado Springs City Council established the following fees to be charged by the City's animal control services contractor pursuant to Chapter 6 of the Code of the City of Colorado Springs 2001, as amended:

Section 2. Veterinarians issuing a dog or cat license pursuant to City Code Article 8, Chapter 6 may retain two dollars (\$2.00) of the fee for each license issued by that veterinarian and shall surrender all other funds to the City's animal control services contractor as the contractor may direct.


Section 3. This resolution shall be effective as of January 1, 2021 and shall remain in effect until amended or superseded.
