John Bissett, Vice Chairman, JM Weston Homes, Housing and Building Association (HBA) of Colorado, provided a briefing on the Careers in Construction Colorado (CICC) program, a workforce development initiative of the Associated General Contractors and the HBA. She identified the CICC Board of Directors, vision, mission, and values. Mr. Bissett gave a brief history of the program, number of students enrolled, current school year/cumulative program statistics, and Colorado Springs Chapter statistics for 2020-2021.

Councilmember Henjum asked if the program expands outside of City limits to southern Colorado. Mr. Bissett stated the CICC offers nonfinancial assistance to activities and schools in Pueblo, but financial support is restricted to Colorado Springs.

Councilmember Henjum asked if there is target goal for placing students in construction careers. Mr. Bissett stated ideally, they would like to place fifty percent of students.

Renee Zentz, HBA, CEO/CICC President, gave an overview of life skills provided by the program and the placement of students throughout the community even outside of the construction industry. She also expressed appreciation for City Council and the Mayor's support.

Several Councilmembers expressed their appreciation for the skill set

being offered to the students in the community.

Councilmember Donelson asked what happens to the completed houses. Mr. Bissett stated they sell them and invest the proceeds back into the program.

President Strand requested City Council observe the students during one of their training programs.

Kris Lewis, Executive Director/CEO, Pikes Peak Habitat for Humanity (PPHFH), provided an update for PPFH fiscal year (FY) 2021 which included statistics, who they serve, major happenings in FY2021-FY2022, second Restore opening, Country Living, Fountain, The Ridge at Sand Creek, Colorado Springs, Micah's View, Fountain, expansion of their repair program, funding, and expenses.

President Strand asked for more information regarding Micah's View. Ms. Lewis gave a brief history regarding Micah and his contributions to the PPFH and the community.

Councilmember Henjum asked how a person would go about purchasing a PPFH home. Ms. Lewis stated they would need to complete an application on their website.

Lieutenant General Harry Raduege, CEO and Board President, National Cybersecurity Center (NCC), provided an update for the NCC. He provided an overview of his background, the history of the NCC, their background, mission, programs, cybersecurity for state leaders, Colorado cybersecurity resource center (CCRC), CCRC mission, and their Colorado K-12 cyber initiative.

President Strand asked if the NCC was open to the public. Lt. Raduege confirmed it was.

Councilmember Henjum requested additional information regarding the partnership with the office supply company. Lt. Raduege stated the NCC is being utilized as a showroom which provides a unique environment.

Councilmember Fortune asked if the NCC is also working on election security. Forrest Senti, Vice President of Programs and Operations, NCC, gave an overview of the process for Secure the Vote.

Councilmember Donelson asked if any of the current projects are classified. Lt. Raduege stated nothing they are currently working on is classified, but they are working on building a secure sensitive compartmented information facility (SCIF).

Councilmember Helms requested additional information regarding their work with the United States Air Force Academy and the City regarding cyber security. Lt. Raduege explained his involvement with Cyber Works at the USAFA as a senior advisor and his collaboration with Catalyst Campus, United States (US) Space Force, US Space Command, North American Aerospace Defense Command (NORAD), US Northern Command, Cheyenne Mountain, and Schriever Air Force Base.

Carl Schueler, Comprehensive Planning Manager, Planning and Community Development Department, presented the Resolution

authorizing the Barnes Center Metropolitan District in the form of limited tax general obligation bonds in an aggregate amount not to exceed \$1,313,796.51. He provided a summary, reasons for changes, questions/comments from the Budget Committee, and next steps.

Councilmember Henjum asked who currently makes up the District Board. Kevin Walker, representing the district, stated the board is currently made up of the original developer team which includes the developer's accountant and broker. He stated they are in the middle of an election for two vacancies.

Councilmember Henjum asked how many of the properties have been sold or built. Mr. Walker stated both properties have been sold and one of them has been sold to an adjacent apartment complex to expand the existing apartment complex which is the rationale for increasing the interest rate.

Steve Posey, HUD Program Manager, Planning and Community Development resented the Resolution to approve the draft 2022 Annual Action Plan (AAP) for United States Department of Housing and Urban Development (HUD) submittal. He provided an overview of the role of the AAP, AAP priorities, people served, partnerships, productivity, AAP communications, and planning framework. Mr. Posey went over the 2022 total estimated budget, 2022 program budgets, public participation, strategies, and next steps.

Councilmember Henjum asked how much was funded by the Coronavirus Aid, Relief, and Economic Security (CARES) Act. Barb Van Hoy, Analyst II, Planning and Community Development, stated approximately \$10 million.

Councilmember Henjum asked for additional information regarding how this plan will be administered. Mr. Posey stated they have received approval to add three additional grant funded positions and a large portion of the CARES Act funds has been spent down due to the operation of the

homeless isolation shelter.

Councilmember Murray asked which Councilmembers will be part of the selection committee for the Chief of Police in lieu of Colorado Springs Police Chief Vince Niski's pending retirement and requested he be part of it as well. Councilmember Fortune stated she looks forward with working with the other members of City Council and expressed appreciation for the opportunity.

Councilmember Henjum stated citizen Judith Rice-Jones attended an exceptionally well-done emergency preparedness workshop put on by The Church of Jesus Christ of Latter-day Saints.

Councilmember Avila stated she has been asking for several years for captions for SpringsTV and Comcast broadcasts of the City Council meetings for members of the community who are hearing impaired, and it needs to become a priority of the City.

President Strand stated he and several other Councilmembers attended the State of the Region with El Paso County Board of Commissioners Chair Stan Vanderwerf, the 2022 State of the State with Governor Polis, the Proclamation of appreciation ceremonies for District 11 and District 2 School Boards, the farewell event for Nick Jimenez, Director of Government and Regulatory Affairs with Comcast, and the Martin Luther King Jr. event.
