

How Public Health Prepares for Emergencies: Robust Planning

- Emergency preparedness and response is a key priority for Public Health
- Public Health developed numerous preparedness and response plans after 9/11
- All Public Health staff are required to complete incident command system and emergency preparedness training during the first three months of hire, and additional trainings as related to their role
- Exercises are conducted to learn lessons and continually improve upon plans with state and local partners – including the Southcentral Healthcare Coalition
- Nearly half of Public Health staff (78, or 49.5%) have been re-assigned to COVID response activities to mount and sustain robust COVID-19 response



COVID-19 Response Highlights El Paso County Public Health

- **Planning and Response:** Public Health has been leading the charge in organizing partners, including those from the Emergency Coordination Center (ECC), Incident Command System (ICS), Continuity of Operations planning, Emergency Preparedness, Coroner's Office, Pikes Peak Regional Office of Emergency Management (PPROEM) and the Joint Information Center (JIC).
- **Disease Control**: Working around the clock to investigate and conduct contact tracing of cases, issue isolation and quarantine letters, and identify proactive strategies for high-risk populations.
- **Data analysis and research:** Public Health Data team has been developing models and projections, working actively with hospitals, researching and studying COVID-19, guiding science and data-driven decisions.
 - This week we will be launching a new data dashboard live on our public-facing website
- **Communication**: Presenting accurate, transparent and credible information in this unprecedented pandemic and fast-paced, evolving situation.
- **Education:** Educating partners, citizens, businesses and people about etiology, epidemiology and appropriate standards of response to COVID-19.

COVID-19 Response Highlights Collaboration

Public Health Partners in the Community

- Pikes Peak United Way: Providing staff for the highly-utilized public call center for El Paso and Teller Counties. Providing financial assistance to residents including through the PPUW and Pikes Peak Community Foundation Emergency Response Fund.
- PPROEM: Facilitating PPE (personal protective equipment) and cloth mask donation drives for first responders and emergency staff.
- Local Food Assistance: The Salvation Army, COSILoveYou, Pikes Peak
 United Way, Care and Share Food Bank, Colorado Springs Food
 Rescue and Silver Key providing a variety of food assistance
 programs to those in need and the elderly.



COVID-19 Response Highlights Collaboration

Public Health Partners in the Community

- Coroner's Office: Ten Coroner's investigators assisting in epidemiological investigations and Dr. Leon Kelly serving as Deputy Medical Director.
- UCCS Beth-El College of Nursing: 35 students and 5 faculty members supporting epidemiological investigations and disease control measures.
- UCHealth: Hosted first local testing site and now FEMAsponsored site, which was recognized by White House. Expanded testing for high-risk populations (health care workers, first responders, those over the age of 65)



COVID-19 Response Highlights Collaboration

Public Health Partners in the Community

- Homeless Isolation Center: City of Colorado Springs, Public Health, El Paso County and Community Health Partnership working together to set up Homeless Isolation Center in City Auditorium.
- Local Schools: Facilitating e-learning for students, providing technology tools to continue learning from home, providing free meals to students.
- Business & Employment Resources: Pikes Peak Small Business
 Development Center, Colorado Springs Chamber & EDC, and Pikes
 Peak Workforce Center assisting local businesses and individuals
 with coaching, financial assistance and employment services.




















COVID-19 Cases and Deaths per 100k










El Paso County COVID-19 Case Demographics


Recovered Cases

 - Not Hospitalized + 14 days elapsed since case reported


Non-confirmed Recovered Cases as of April 13


171 out of 248

EPC COVID-19 Hospitalizations. Data from CEDRS, (13-April-2020). El Paso County Public Health Data and Analytics Office.






Contact Tracing

- Identify positive cases quickly
- Identify contacts
- Isolation and Quarantine
- Prioritize high-risk or clusters
- Building capacity for opening





A Phased Approach to Restart

- Phase I Slow the spread
- Phase II Reopen, state by state
- Phase III Establish protection then lift all restrictions
- Phase IV Rebuild our readiness for the next pandemic

Phase I

Slow the spread

- Trigger
 - Community spread
- Techniques
 - Population-level controls
 - Extensive social distancing
- Actions
 - Save lives
 - Build capacities (e.g. testing, care, tracking)
 - Gain knowledge of COVID-19

Phase II

Reopen, deliberately and incrementally

- Trigger
 - Controlled spread sustained reduction in new cases
- Techniques
 - Case-level controls contact tracing and testing
 - Reduced social distancing business and schools
- Actions
 - Begin step-by-step return to normal for most activities still no large crowds
 - High-risk populations remain sheltered

Phase III

Establish protection and lift all restrictions

- Trigger
 - Effective therapeutics or vaccines
- Techniques
 - Case-level controls continue
 - Medical interventions and vaccines
- Actions
 - Phased deployment of medical interventions
 - Return to normal social gatherings

Phase IV

Prepare for the next pandemic

- Trigger
 - Now
- Techniques
 - National action priorities for infectious disease response
- Actions
 - Accelerated vaccine and therapeutic development technologies
 - Improved surge capacity for health care systems
 - National forecasting systems for infectious diseases
 - National standards for preparedness and response
