Councilmember Williams read a Resolution recognizing October 2021 as Domestic Violence Awareness Month.

Ann Markley, CEO, TESSA of Colorado Springs, gave an overview of TESSA's domestic violence awareness campaign. She stated this month is an effort to bring awareness to the community and to acknowledge domestic violence survivors.

Moddy Dennis, Victim Advocacy Coordinator, Colorado Springs Police Department (CSPD), spoke about the dedication and commitment of the CSPD regarding investigating cases of domestic violence crimes, supporting victims, and holding offenders accountable.

Councilmember Henjum asked if there has been an increase in domestic violence due to COVID. Ms. Markley stated it has increased by fifty percent.

Councilmember Helms asked if victims of domestic violence are required to press charges in order for someone to be arrested. Vince Nicki, Chief, CSPD, stated it makes the prosecution easier if the victim will testify, but if an Officer has probable cause, they may move forward with an arrest.

Councilmember Murray asked if a person is permitted to carry a weapon if they are convicted of domestic violence. Chief Niski stated they are not.

Citizen Mark Beals spoke about the first amendment, spirited discussions in school board meetings, and the FBI's involvement in them.

Charae McDaniel, Chief Financial Officer presented the Resolution accepting and endorsing recommended expenditures from the Lodgers and Automobile Rental Tax (LART) special fund for inclusion in the 2022 budget. She stated the LART Citizens' Advisory Committee does a very thorough job of reviewing and tracking these events prior to making recommendations to City Council for approval.

President Strand gave an overview of the total anticipated revenue, appropriations, and remaining funds.

Councilmember Avila stated communities of color are not represented in the LART Citizens' Advisory Committee recommended projects/events. She stated the Fiestas Padrias cultural event which applied for \$40,000, only \$10,000 was awarded out of the \$8.5 M available, the Colorado Springs Sports Corporation was awarded \$120,000.

Councilmember Williams stated there are workshops available to assist entities with the application process, there are certain City Council Resolution events which are funded, each of the applications are reviewed to see what the tourism impact to the City would be, and many of the groups appeal to a wide and diverse group of participants. He stated the entirety of the fund is not obligated because the revenue is anticipated, but there is uncertainty with the effect of the pandemic.

Councilmember Donelson stated the recommended events are attended by citizens from all different groups as well as people from out of town.

Councilmember Murray requested Councilmember Avila's questions regarding the LART Citizens' Advisory Committee recommendations be answered in writing and asked if a pyrotechnic event could be done in her district.

Councilmember Henjum requested the LART Citizens' Advisory Committee provide City Council a list of their values and how they base their decisions.

Jeff Greene, Chief of Staff, stated the Colorado Springs Sports Corporation stepped forward at the Mayor's request to help facilitate the City's 4th of July event which was during the heat of the pandemic and was very successful. He stated the City does need to be sensitive that these

events take into account equity and ensure the parks utilized for these events can be enjoyed by all.

P.K. McPherson, Chair, LART Citizens' Advisory Committee, stated the LART Citizens' Advisory Committee works diligently to ensure the community is represented on all fronts, but they are only able to review the applications submitted. She stated there is room to expand the awareness of LART and there will be a March off-cycle where people can apply for the remaining funds.

David Siegel, Vice Chair, LART Citizens' Advisory Committee, stated the LART Citizens' Advisory Committee members take great responsibility in reviewing LART applications very seriously and making sure racism is not present in making decisions.

Councilmember Avila requested the makeup of the members of the LART Citizens' Advisory Committee which makes these decisions and stated the outreach process needs to be improved.

Councilmember Donelson stated the revenue derived from the LART tax may be expended for the purpose of tourism and promotion in the City and the Pikes Peak Region and the LART Citizen Advisory Committee determines the funding based on the amount of tourism the event brings.

Citizens Michael Ung, Alea Vigil, David Walmoso, and Brian Talk spoke on behalf of Jaymen Johnson's Speakeasy Vape Lounge and Cannabis Club Dab Bar and stated it brings tourism dollars to the City.

Citizen Jaymen Johnson thanked his supporters and stated people will travel great distances to attend cultural events.

Councilmember Henjum stated there is potentially room for the LART Citizen Advisory Committee to be integrating the values of equality in the process of meeting the mission of LART.
