Lodgers and Automobile Rental Tax Citizen Advisory Committee

On April 8, 2025, City Council passed a resolution rescinding Resolution No. 25-21 and amending Resolution No. 254-80 to restructure the LART Citizen Advisory Committee membership. These changes aim to ensure the Committee's composition aligns with the primary purpose of the Lodgers and Automobile Rental Tax – to attract visitors and stimulate the economy of Colorado Springs and the greater Pikes Peak Region.

Councilmember Liaisons Lynette Crow-Iverson and Nancy Henjum qualified the applicants for the revised positions. The following updates are recommended:

- Fred Veitch, who has served as an alternate member since March 14, 2023, is recommended for appointment as a voting member for the Citizen-at-large position.
- Christen Rumsey is recommended for reclassification from ex-officio to voting member status representing the Automobile Rental Industry.
