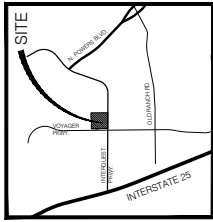


VICINITY MAP

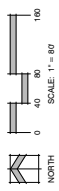
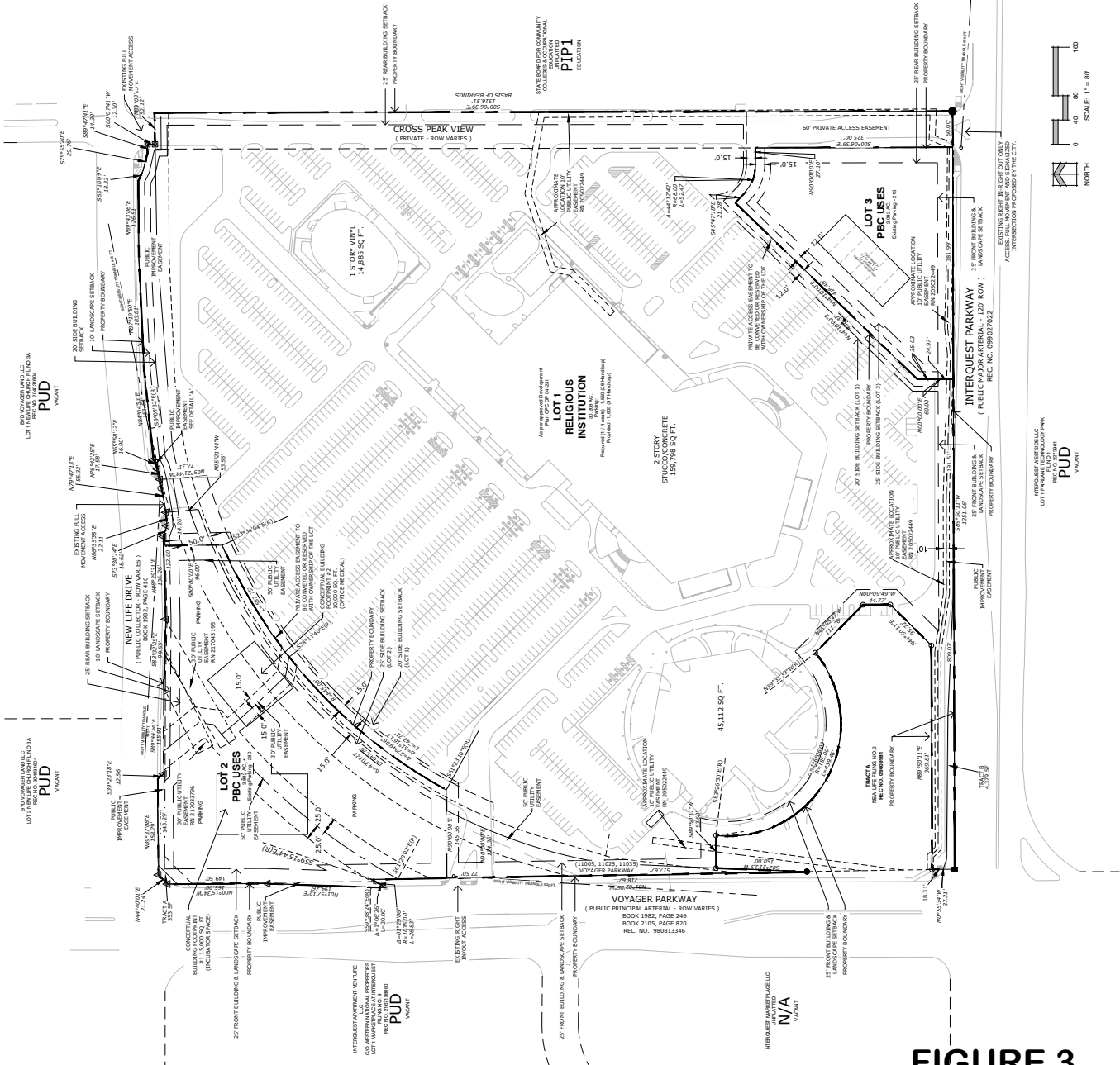
