

ORDINANCE NO. 22-18

AN ORDINANCE AMENDING ORDINANCE NO. 21-112 (2022 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE TRAILS, OPEN SPACE AND PARKS FUND IN THE AMOUNT OF \$2,819,000 TO COMPLETE THE PHASE II ACQUISITION OF UP TO 85 ACRES OF PROPERTY FOR THE PURPOSE OF PUBLIC OPEN SPACE AND TRAILS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:


Section 1. That Ordinance No. 21-112 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$2,819,000 inclusive of the purchase price, professional services fee, and direct real estate acquisition costs for acquisition of up to 85 acres of property known as the phase II portion of the Fisher Canyon property for the purpose of public open space and trails. The source of funds for the land acquisition is the TOPS fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.


