## Old Colorado City Downtown Development Authority (DDA) Board

The Old Colorado City DDA Board consists of eleven members: one Councilmember and ten qualified electors (residents, landowners, or business lessees within the DDA boundaries). Two additional appointments are still required to complete the Board roster, with terms set to expire on June 30, 2027, and June 30, 2028, respectively, as outlined in the establishing ordinance.

Councilmembers Brandy Williams and Lynette Crow-Iverson, along with Jariah Walker, Executive Director of the Urban Renewal Authority, conducted interviews with applicants on November 3 and November 21, 2026.
