

ORDINANCE NO. 25 - 84

AN ORDINANCE PROVIDING FOR THE PLATTING OF  
BLOCKS 205 AND 244 IN EVERGREEN CEMETERY

WHEREAS, due to the continued demand for burial and cremation sites at the City cemeteries, two additional platted blocks are necessary at Evergreen Cemetery.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY  
OF COLORADO SPRINGS:

Section 1. Pursuant to City Code § 14.2.108 additional burial and cremation spaces are hereby established at Evergreen Cemetery. This ordinance approves the platting of Blocks 205 and 244 at said Evergreen Cemetery.

Section 2. Block 205 shall consist of 552 casket burial spaces and 718 cremation spaces.

Section 3. Block 244 shall consist of seven thousand five hundred (7,500) square feet, sold collectively as one estate.

Section 4. Any and all improvements to or memorials placed on the spaces within Block 205 and Block 244 shall comply with the Rules and Regulations of Evergreen and Fairview Cemeteries, dated May 15, 2024, and as amended.


Section 4. This Ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 5. Council deems it appropriate that this Ordinance be published by title and summary prepared by the City Clerk and that this Ordinance be available for

inspection and acquisition in the office of the City Clerk.


