- ➤ The design standards as proposed by ONEN are those as referenced in 2000 and have not been updated since

### **General Information**



#### **Site Details:**

- ➤ 1982 Old North End Historic District listed on National Register of Historic Places
  - The historic District contains roughly 675 properties
  - represent cultural influences of English architecture, with some adaptations and architectural variations
- 2000 Historic Preservation Overlay zone district created (Ord. 00-147)
- > Draft or interim design standards were present and discussed, but not adopted

#### **Public Notification and Involvement:**

- ➤ Public notice was mailed to 1,417 property owners prior to the City's Historic Preservation Board hearing
- ➤ No City-initiated efforts were undertaken to engage the residents or hold neighborhood meeting(s) to collect feedback

# Purpose and Use of Design Standards



#### **Purpose**

City Code § 7.5.1602 *Definitions - Design Standards*:

"Written statements adopted by City Council resolution as criteria for use by the Board in the consideration of an application for a report of acceptability for properties with historic preservation overlay zoning."

#### <u>Use</u>

- ➤ Used by the City's Historic Preservation Board and City Planning staff as additional review criteria when considering an application (Report of Acceptability) in the overlay zoning.
- ➤ The proposed design standards would only apply to new construction work (i.e. decks, additions, solar panels, etc.) affecting the exterior of properties that requires a building permit.

WHILE NOT ADOPTED, THE PROPOSED DESIGN STANDARDS ARE USED TO GUIDE UNDERTAKINGS IN THE OLD NORTH END HISTORIC DISTRICT.

#### **Guidelines vs. Standards**

- ➤ Guidelines Explanatory information of historic characteristics suitable for preservation, and techniques and materials appropriate to make informed decisions when applying the review criteria
- Standards Explanatory statements used as additional review criteria

#### **Potential Conflicts**

➤ Examples: Rooftop Solar (District Standard #4), Preserve Mountain Views (Area-wide Standard #4), and Dimensional Standards (Subarea Standards)

#### **Alignment**

- Modern planning guidance (i.e. PlanCOS and HistoricCOS)
- Consistency with current construction standards (i.e. IBC)
- > Treatment Standards and Guidelines (i.e. Secretary of Interior)

#### ADDITIONAL PUBLIC AND EXPERT VETTING COULD RESOLVE CONFLICTS.

# Alternatives/Recommendation



#### **Alternatives:**

- 1. Adopt the design standards as presented;
- Remand the design standards back to the Historic Preservation Board and direct staff to hold neighborhood meetings before formal consideration by City Council. (Uncertain timeline)

#### **Recommended Action**

Provide direction to staff on whether or not to schedule the design standards for a formal City Council hearing, or to engage in additional public process.
