AN ORDINANCE REINSTATING AND AMENDING SECTION 507 (LICENSE FEES ENUMERATED) OF PART 5 (LICENSE FEES) OF ARTICLE 1 (GENERAL BUSINESS LICENSE PROVISIONS) OF CHAPTER 2 (BUSINESS LICENSING, LIQUOR REGULATION AND TAXATION) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO BUSINESS LICENSE FEES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 507 (License Fees Enumerated) of Part 5 (License Fees) of Article 1 (General Business License Requirements) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the Code of the City of Colorado Springs 2001, as amended, is reinstated and amended to read as follows:

Except for any and all resolutions setting fees for medical marijuana business licenses under Part 1 (Medical Marijuana License Code) of Article 3 (Sales of Goods and Services) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation), this ordinance shall supersede and rescind any and all prior resolutions setting any amount of fee for any license subject to the General Licensing Code of the City of Colorado Springs, including without limitation Resolution No. 197-02, as amended by Resolution 158-08.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
