6. Citizen Discussion

Citizen John Kilbury spoke about the condition of sidewalks and flower beds in the downtown area.

Citizen Charles Barber spoke about options for handling the Pueblo stormwater case, offering alternative drainage solutions.

Citizen Gerald Miller spoke about damage to his grill and developed a connection between Cities with NFL team and fewer potholes.

Citizens Lara Rowell and Walter Lawson spoke in opposition to the proposed park land swap with The Broadmoor. Councilmember King stated there is a town hall meeting scheduled and requested a copy of her questions so answers can be prepared. Councilmember Murray requested the answers be provided to Council in writing.

Citizen Deborah Stout-Meininger expressed concerns about the Southern Delivery System and funds spent on C4C and Urban Development.

Citizen Chris Wynkoop spoke about snow on the local sidewalks, stating companies hired to plow parking lots for businesses should also shovel the sidewalks.

Councilmember King stated he pulled this item off the Consent Calendar because the language in paragraph 2. of the ordinance states, "...payment of all applicable fees and costs...", which he finds to be inconsistent with the title of this ordinance which pertains to the elimination of reconnection fees.

Ken Burgess, Attorney, CSU, explained the charges referred to in the ordinance pertain to service level changes. An elimination of all reconnection fees would be better handled through a tariff change.

Councilmember Pico explained this ordinance will remove reconnection charges amounting to thousands of dollars and impose a \$30 reconnection fee. A tariff change will be drafted to clarify reconnection fees will only apply to development changes associated with the reconnection of service.

Carl Schueler, Planning Manager, Comprehensive Planning, provided a summary of the changes to this proposal adding a written statement of support from the McDonald's property owner has not been received. Options include moving forward with formation of the district without including the McDonald's property or excluding the property from the

proposed district.

Danny Mientka with The Equity Group, the developer, stated his efforts to have the McDonald's property owners appear before Council or provide a written statement of support have been unsuccessful. He does not believe there is any resistance to the inclusion in the district on behalf of the McDonald's Corporation, but there is bureaucracy prohibiting a timely response from the corporation in this matter. There is no time to delay this action any longer due to time constraints posed by the submission requirements of the May election.

Councilmember Knight asked if the BID Board will be paid or voluntary and why three properties in the midst of the proposed district are not crucial to this action. Mr. Schueler stated all board members will be elected strictly on a voluntary basis. Mr. Mientka stated the three properties in question are residential and cannot be included in a BID. If purchased by the developer, they will be added to the BID at a later date. Councilmember Knight requested a spelling error in section 9., Dissolution, of the Operating Plan, be corrected to read, "... seek to dissolve..." rather than, "...seed to dissolve...".

Council discussed the planned financial arrangements of the development in detail with Mr. Mientka and Mr. Schueler.

Citizens Longinos Gonzalez and Deborah Stout-Meiningner spoke in opposition to the development including the McDonald's property.

Motion by Councilmember Murray, seconded by Councilmember King, to amend the motion to exclude McDonald's property. The motion passed by a vote of 6-3-0.
