



1. With the four address changes that are required due to this roadway realignment. Each separate lot will need a separate address change. Meaning, one address change form for each lot.

All of the addresses in the R.O.W. can be on one separate address change. (To be clear 5717 Airport Rd is a CSU water line w/electrical service, 5920 Airport Rd is still an active traffic signal, & 5330 Airport Rd is still active as a pump and well). Total of 4 address changes will be required. Here is the link for the information needed for each separate address change. Total fees due \$200.00. ### Criteria for Approval

Planning Commission's Decision: The Planning Commission shall review the Street Name Change application in accordance with Subsection [7.5.407.D.2](#) (Planning Commission, FBZ Review Board) based on the requirements of Subsection [7.4.304.H](#) (Street Names). Upon a determination that the application does not meet the requirements of Subsection [7.4.304.H](#), the Planning Commission shall deny the application. If the application meets the requirements of Subsection [7.4.304.H](#), the Planning Commission may approve or deny the application in its discretion.
