# Waste Containment Service

Springs Waste

Cart rent \$5/month or \$60/year

Bestway

1x fee of \$40 dumpster bar/lids \$300

Purchase Bear resistant cart -\$245

Ace Hardware

Toter Bear tough 96 gal Cart \$229



- Waste haulers can provide bear resistant containers for sale or a small monthly fee
- Interagency Grizzly Bear Committee approved products
- Competitive market will drive change

# Waste Containment Options

- Residents may keep trash in suitable enclosure until day of pickup
- Residents may freeze waste until trash day
- Residents may rinse trash containers to remove attractants.



# Ordinance Components

- Ordinance enforced west of I-25
  - Waste secured in bear resistant container
- or
- Waste secured in suitable enclosure until 5:00 a.m. on trash pickup day
  - For commercial establishments, waste secured in bear resistant container or secured dumpster enclosure
  - Ordinance enforced by Code Enforcement on complaint basis





# Manitou Springs

- Bear ordinance enacted January 1, 2018
- Enforced by Code Enforcement
- 106 Calls made to Code Enforcement
- 95 warnings issued
- Six fees assessed; average \$140.00
- Response to complaints is approximately 10% of annual workload
