AN ORDINANCE AMENDING ORDINANANCE NO 18-118 (2019 BUDGET APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE AIRPORT CAPITAL IMPROVEMENT PROGRAM (CIP) FUND IN THE AMOUNT OF \$2,700,000 FOR AIRPORT LAND DEVELOPMENT AND THE AIRPORT MASTER PLAN

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Ordinance no. 18-118 is hereby amended by increasing the Airport Capital Improvement Program (CIP) fund expenditure appropriation in the amount of \$2,700,000 for the following projects at the Colorado Springs Airport:

- Land Development (\$2,500,000)
- Master Plan Development (\$200,000)

The source of funds is the available fund balance in the Airport CIP fund.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
