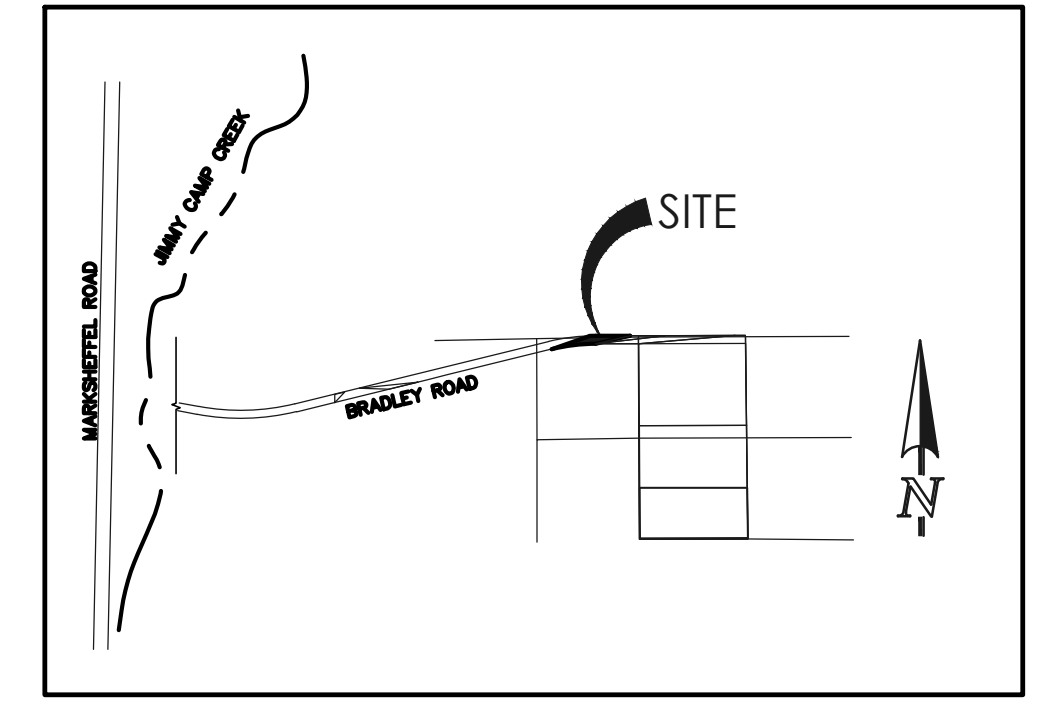
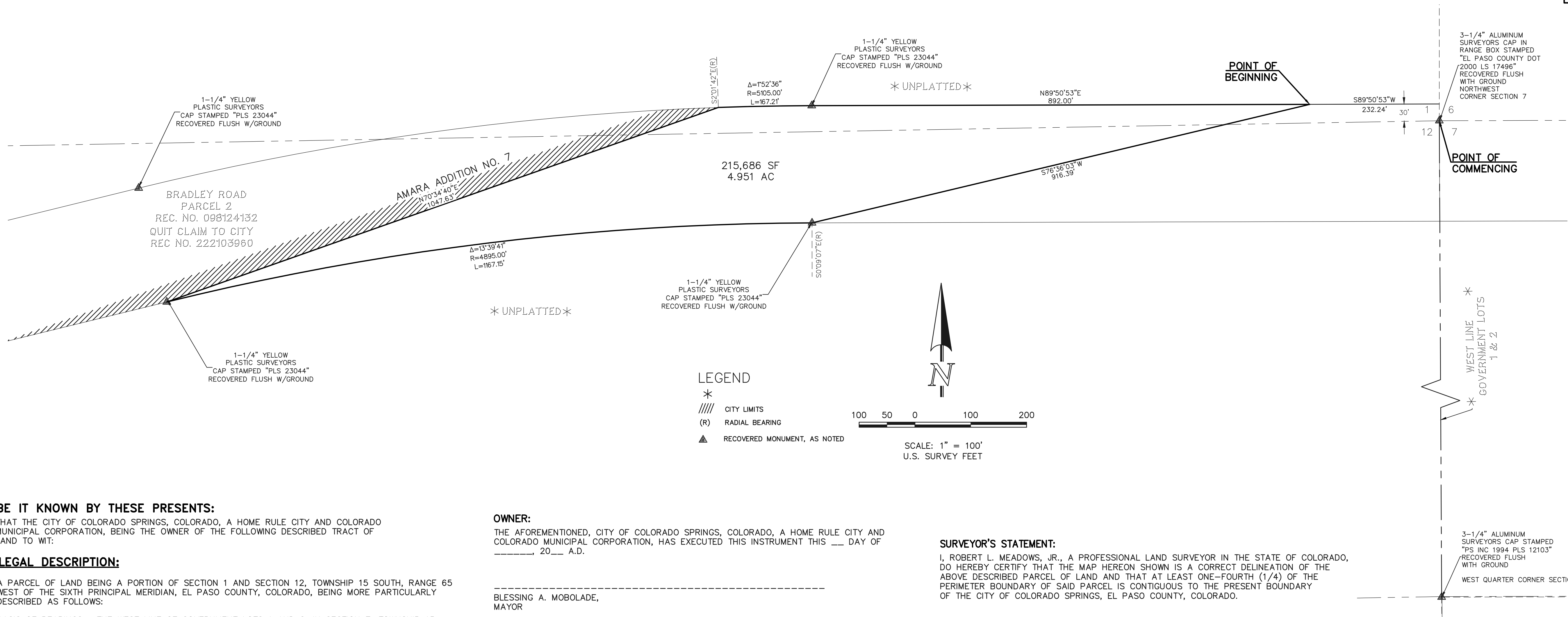


ANNEXATION PLAT AMARA ADDITION NO. 8

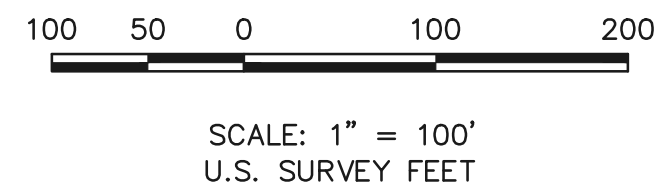


VICINITY MAP

THENCE S89°50'53"W, ON THE NORTHERLY RIGHT OF WAY LINE OF SAID BRADLEY ROAD, PARCEL 2, A DISTANCE OF 232.24 FEET TO THE POINT OF BEGINNING;
