AN ORDINANCE AMENDING SECTION 1704 (SHORT TERM RENTAL UNIT PERMIT REVIEW CRITERIA) OF PART 17 (SHORT TERM RENTAL UNIT) OF ARTICLE 5 (ADMINISTRATION AND PROCEDURES) OF CHAPTER 7 (PLANNING, DEVELOPMENT AND BUILDING) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO REMITTANCE OF TAX AND SHORT TERM RENTAL UNIT PERMIT REVIEW CRITERIA

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 1704 (Short Term Rental Unit Permit Review Criteria) of Part 17 (Short Term Rental Unit) of Article 5 (Administration and Procedures) of Chapter 7 (Planning, Development and Building) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

7.5.1704: SHORT TERM RENTAL UNIT PERMIT REVIEW CRITERIA:

The Manager may approve or approve with conditions an application for, or renewal of, a short term rental unit permit if the following criteria and specific regulations are met:

C. The owner shall obtain a Sales Tax license from the City's Sales Tax Office, and shall not be indebted or obligated in any manner to the City.

* * *

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Any person violating Paragraph C of Section 1704 (Short Term

Rental Unit Permit Review Criteria) of Part 17 (Short Term Rental Unit) of Article 5

(Administration and Procedures) of Chapter 7 (Planning, Development and

Building) shall be subject to the remedies provided in Section 1005 (Remedies) of

Part 10 (Zoning Enforcement) of Article 5 (Administration and Procedures) of

Chapter 7 (Planning, Development and Building) of the Code of the City of

Colorado Springs 2001, as amended.

Section 4. Council deems it appropriate that this ordinance be

published by title and summary prepared by the City Clerk and that this

ordinance be available for inspection and acquisition in the office of the City

Clerk.
