THE NORTH END

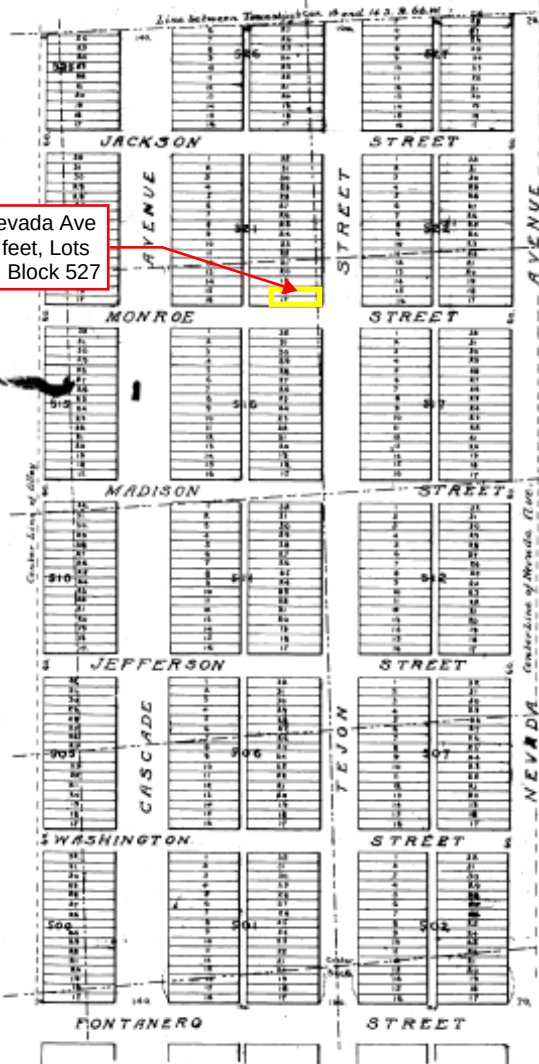

W. lying East of Center line of Olney, said Center line being Two hundred feet (200 feet) West of West line of Cascade Ave. and parallel thereto, also all that part of the East one half (NW) of NE 1/4 Sec. 6 T.14.3. N. 66. W. lying West of the center line of Nevada Ave. said Center line being 70 feet East of West line of Nevada Ave. and parallel thereto, and all that part of NW 1/4 NW 1/4 of said Sec. 6 lying North of N line of Fontanero St. and East of Center line of Olney, said Center line being Two hundred (200) feet West of West line of Cascade Ave. and all that part of NE 1/4 NE 1/4 of said Sec. 6 lying North of North line of Fontanero St. and all that part of NW 1/4 NW 1/4 of said Sec. 6 lying North of North line of Fontanero St. and West of Center line of Nevada Ave. said Center line being Seventy two feet East of West line of Nevada Ave. have this day laid out Sub-divided and platted the same in accordance with the Plat Map hereto annexed, and hereby authorize the same to be filed according to the Statute in such case provided, and the said Jerome B. Wheeler, Louis R. Ehrich, and J. A. Hayes do hereby acknowledge that the said Map or Plat is drawn to a fixed scale as indicated thereon, and accurately sets forth and shows all Streets, Avenues and Highways with the names and widths thereof, and all Lots and blocks with their boundaries and dimensions.

The size of all Lots except fractional lots on North exterior boundary is 25 feet by 130 feet.
