AN ORDINANCE AMENDING ORDINANCE NO. 17-116 (2018 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE GENERAL FUND IN THE AMOUNT OF \$300,000 FOR ADDITIONAL POSITIONS AND RESOURCES TO ENHANCE THE CITY'S AMERICANS WITH DISABILITIES ACT TITLE II (ADA) PROGRAM

WHEREAS, the City has significant obligations under the ADA to not discriminate against individuals with disabilities in its services, programs, or activities and to make its facilities accessible; and

WHEREAS, the total funding requirement of this program in 2018 is \$500,000. NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF

COLORADO SPRINGS:

Section 1. That Ordinance No. 17-116 is hereby amended by increasing the General Fund expenditure appropriation in the amount of \$300,000 for additional positions and resources to enhance the City's Americans with Disabilities Act Title II (ADA) Program. The source of funds is the General Fund available fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
