AN ORDINANCE AMENDING SECTION 212 (UNLAWFUL TRANSFER OF MARIJUANA) OF PART 2 (OTHER **WEAPONS** DANGEROUS AND SUBSTANCES) OF ARTICLE 7 (DANGEROUS **WEAPONS** SUBSTANCES) OF CHAPTER 9 (PUBLIC OFFENSES) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001. AS AMENDED. PERTAINING TO THE UNLAWFUL TRANSFER OF MARIJUANA AND **PROVIDING** PENALTIES FOR THE VIOLATION THEREOF

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 212 (Unlawful Transfer of Marijuana) of Part 2 (Other Dangerous Weapons and Substances) of Article 7 (Dangerous Weapons and Substances) of Chapter 9 (Public Offenses) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

9.7.212: UNLAWFUL TRANSFER OF MARIJUANA:

A. * * *

B. Except as authorized by part 1 of article 2 of chapter 2, it is unlawful for a person to knowingly dispense, sell, distribute, or possess with intent to manufacture, dispense, sell, or distribute not more than four (4) ounces of marijuana or not more than two (2) ounces of marijuana concentrate; or attempt, induce, attempt to induce, or conspire with one (1) or more other persons, to dispense, sell, distribute, or possess with intent to manufacture, dispense, sell, or distribute not more than four (4) ounces of marijuana or not more than two (2) ounces of marijuana concentrate.

Section 2. Any person convicted of violating Section 212 (Unlawful

Transfer of Marijuana) of Part 2 (Other Dangerous Weapons and Substances) of

Article 7 (Dangerous Weapons and Substances) of Chapter 9 (Public Offenses)

shall be punished as provided in Section 201 (General Penalty) and Section 202

(Minor Offenders) of Part 2 (General Penalty) of Article 1 (Administration) of

Chapter 1 (Administration, Personnel, and Finance) of the Code of the City of

Colorado Springs 2001, as amended.

This ordinance shall be in full force and effect from and after Section 3.
