

RESOLUTION NO. 87-17

A RESOLUTION CORRECTING A CLERICAL ERROR IN RESOLUTION NO. 78-17, A RESOLUTION RESCINDING RESOLUTION NO. 120-11 AND RESOLUTION NO. 153-11 AND ESTABLISHING MEDICAL MARIJUANA BUSINESS APPLICATION AND LICENSE FEES AND CHARGES

WHEREAS, on June 27, 2017, City Council adopted Resolution No. 78-17, A Resolution Rescinding Resolution No. 120-11 and Resolution No. 153-11 and Establishing Medical Marijuana Business Application and License Fees and Charges (See **Exhibit 1**, attached and made a part of this Resolution); and

WHEREAS, the City Council's Special Marijuana Working Group discussed and recommended that the Manager Registration Fee would be reduced from \$500.00 to \$200.00 and that City staff notified all Medical Marijuana business licensees of the recommendation; and

WHEREAS, City staff publically discussed and announced that the Manager Registration Fee would be reduced from \$500.00 to \$200.00; and

WHEREAS, Exhibit A attached and made a part of Resolution No. 78-17, did not reflect the reduction in the Manager Registration Fee; and


WHEREAS, City Council desires to correct the clerical error contained in Exhibit A attached and made a part of Resolution No. 78-17.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The "*Manager Registration Fee (if not an owner)*" section of Exhibit A, attached and made a part of City Council Resolution No. 78-17 (Exhibit 1, attached and made a part of this Resolution) shall be corrected to read \$200.00.


Section 2. That this Resolution shall be effective immediately upon its passage.

RESOLUTION NO. 78-17

A RESOLUTION RESCINDING RESOLUTION NO. 120-11 AND RESOLUTION NO. 153-11 AND ESTABLISHING MEDICAL MARIJUANA BUSINESS APPLICATION AND LICENSE FEES AND CHARGES

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS, COLORADO

Section 1. Resolution No. 120-11 establishing the fee and charge for Medical Marijuana Business License applications is hereby rescinded as of the close of business on July 31, 2017.

Section 2. Resolution No. 153-11 establishing the fees and charges for Medical Marijuana Business Licenses is hereby rescinded as of the close of business on July 31, 2017.

Section 3. The fees and charges as set forth in Exhibit A, attached and made a part of this Resolution, are hereby established for the processing, review, and enforcement of Medical Marijuana Business Licenses issued by the Office of the City Clerk.

Section 4. These fees and charges shall be effective August 1, 2017 and shall remain effective until amended or rescinded by subsequent Resolution of the City Council.
