**9(a). *Describe change proposed:***

In 2001, prior tenant, TGI Fridays, obtained approval via the City of Colorado Springs building department for the addition of an enclosed greenhouse (“atrium”) to the restaurant premises (see attached re permit #D94905). The local liquor licensing authority of the City of Colorado Springs, however, has no record of this addition to the liquor licensed premises.

New tenant, Springs In My Kilt, L.L.C. dba Tilted Kilt Pub & Eatery is filing this modification of premises application to bring the licensed premises into compliance with State Liquor Code with respect to the atrium addition, and also for approval of various “cosmetic” changes that will be made to convert the premises from a TGI Fridays concept to the Tilted Kilt concept.



It appears that you will be entitled to possession of the premises for which the application is made.


At this time, the premises you desire to license does not appear to be in violation of any Zoning Ordinances of the City of Colorado Springs, Colorado.



