

ORDINANCE NO. 16-35

AN ORDINANCE AMENDING SECTION 507 (LICENSE FEES ENUMERATED) OF PART 5 (LICENSE FEES) OF ARTICLE 1 (GENERAL BUSINESS LICENSE PROVISIONS) OF CHAPTER 2 (BUSINESS LICENSING, LIQUOR REGULATION AND TAXATION) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO MARIJUANA CONSUMPTION CLUB LICENSE FEES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 507 (License Fees Enumerated) of Part 5 (License Fees) of Article 1 (General Business License Provisions) of Chapter 2 (Business Licensing, Liquor Regulation and Taxation) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

2.1.507: LICENSE FEES ENUMERATED:

Fees for licenses subject to this General Licensing Code except for medical marijuana business licenses under article 2, part 1 of this chapter shall be as set forth below. ~~All fees shall be annual fees unless otherwise indicated:~~


