

ORDINANCE NO. 24 - 15

AN ORDINANCE AMENDING ORDINANCE NO. 23-65 (2024 BUDGET APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE PATTY JEWETT GOLF ENTERPRISE FUND IN THE AMOUNT OF \$2,000,000 FOR A PORTION OF THE COST OF REPLACING THE IRRIGATION SYSTEM AT PATTY JEWETT GOLF COURSE

WHEREAS, Patty Jewett and Valley Hi golf courses are operated as separate enterprises of the City of Colorado Springs within the Golf Enterprise Division of Parks, Recreation and Cultural Services; and

WHEREAS, the golf courses at Valley Hi and Patty Jewett have irrigation systems that are at least 38 years old, which is 18 years past their lifespan; and

WHEREAS, American Rescue Plan Act (ARPA) funding totaling \$6.6 million will be utilized to replace the irrigation system at Valley Hi golf course and to replace a portion of the irrigation system at Patty Jewett golf course; and

WHEREAS, the cost of the replacement of irrigation systems at both golf courses has increased significantly since ARPA funding was allocated to the projects, and only one vendor submitted a bid for the projects.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 23-65 is hereby amended by increasing the Patty Jewett Golf Enterprise Fund expenditure appropriation in the amount of \$2,000,000, for a portion of the cost of replacing the irrigation system at Patty Jewett Golf Course. The source of funds is unrestricted Patty Jewett Golf Enterprise Fund balance.


Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.


