ORDINANCE NO. 22-17

AN ORDINANCE AMENDING ORDINANCE NO. 21-112 (2022 APPROPRIATION ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE PIKES PEAK-AMERICA'S MOUNTAIN ENTERPRISE FUND IN THE AMOUNT OF \$500,000 FOR CONTRACT EXTENSIONS RELATED TO THE SUMMIT COMPLEX CONSTRUCTION PROJECT AND SHUTTLE OPERATIONS

WHEREAS, due to the COVID-19 pandemic, increased cost of materials, and supply chain disruptions, the Summit Complex construction project cost is higher than anticipated and has taken longer to complete; and

WHEREAS, due to parking lot and road improvements that will occur during 2022, the enterprise must pay for shuttle operations for the 2022 season.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 21-112 is hereby amended by increasing the Pikes Peak-America's Mountain Enterprise Fund expenditure appropriation in the amount of \$500,000 for contract extensions related to the Summit Complex construction project and shuttle operations. The source of funds is the Pikes Peak-America's Mountain Enterprise fund balance.

Section 3. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
