AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF COLORADO SPRINGS RELATING TO 13.361 ACRES LOCATED WEST OF THE INTERSECTION OF TUTT BOULEVARD AND SORPRESA LANE FROM A/AO (AGRICULTURAL WITH AIRPORT OVERLAY) TO R-5/AO (MULTIFAMILY RESIDENTIAL WITH AIRPORT OVERLAY)

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The zoning map of the City of Colorado Springs is hereby amended by rezoning 13.361 acres located west of the intersection of Tutt Boulevard and Sorpresa Lane, as described in Exhibit A and depicted in Exhibit B, both of which are attached hereto and made a part hereof, from A/AO (Agricultural with Airport Overlay) to R-5/AO (Multi-family with Airport Overlay), pursuant to the Zoning Ordinance of the City of Colorado Springs.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the Office of the City Clerk.


