Section 1. That Ordinance No. 21-112 is hereby amended by increasing the expenditure appropriation of the Lodgers and Automobile Rental Tax (LART) Fund in the amount of \$300,000 for the USOPM 2022 Hall of Fame Festival event. The source of funds is the LART available fund balance and the 2022 estimated revenue in excess of budget.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
