

REQUESTS:

- Additional \$2.5M in private activity bond cap
- Extending the effective date of the ordinance from December 31, 2022 to June 1, 2023

REASONS:

- Development costs are still high
- Interest rates continue to rise
- Need additional time to work through these issues, anticipating closing mid-February

- # of units: 76 new, 51 rehab
- Total Project Cost: \$43,800,000 (original \$37,300,000)
- PAB Funds Requested: up to \$21,500,000 (original ask \$19M)

- Objective 4: Housing for the aging & disabled population
