AN ORDINANCE AMENDING SECTION 102 (INOCULATION REQUIRED FOR DOGS AND CATS) OF ARTICLE 8 (REGULATION OF ANIMALS – PETS) OF CHAPTER 6 (NEIGHBORHOOD VITALITY / COMMUNITY HEALTH) OF THE CODE OF THE CITY OF COLORADO SPRINGS 2001, AS AMENDED, PERTAINING TO INOCULATION REQUIREMENT

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. Section 102 (Inoculation Required for Dogs and Cats) of Article 8 (Regulation of Animals – Pets) of Chapter 6 (Neighborhood Vitality / Community Health) of the Code of the City of Colorado Springs 2001, as amended, is amended to read as follows:

6.8.102: INOCULATION REQUIRED FOR DOGS AND CATS:

A. It shall be the duty of every person who owns or keeps within the City any dog or cat to maintain current inoculation with antirabies vaccine by a licensed veterinarian or a person under the supervision of a licensed veterinarian as permitted pursuant to C.R.S. § 12-315-105(1)(q).

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
