# A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF COLORADO SPRINGS AND EL PASO COUNTY, COLORADO, FOR THE PURPOSE OF SNOW REMOVAL AND SNOW AND ICE CONTROL ON ROADWAY SEGMENTS

WHEREAS, the City of Colorado Springs (the "City") and El Paso County, Colorado (the "County") provide each other mutual cooperation and support for snow removal and snow and ice control on roadway segments throughout the City and the County; and

WHEREAS, the City and the County desire to assist each other with snow removal and snow and ice control efforts throughout the region.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. The City Council finds that an intergovernmental agreement ("IGA") between the City of Colorado Springs and El Paso County, Colorado, for the purpose of snow removal and snow and ice control on roadway segments is in the best interest for the health, safety and welfare of the city's residents.

Section 2. The IGA (attached as "Exhibit A"), effective November 15, 2022, between the City and the County for the purpose of providing mutual support for snow removal and snow and ice control on roadway segments throughout the City and the County is hereby approved.

Section 3. The Mayor and the Public Works Director are hereby authorized to execute and administer the IGA on behalf of the City.

## INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF COLORADO SPRINGS AND EL PASO COUNTY, COLORADO FOR SNOW REMOVAL AND SNOW AND ICE CONTROL

This Intergovernmental Agreement ("Agreement"), dated this 15th day of November, 2022 ("Effective Date"), regarding snow removal and snow and ice control, is made by and between El Paso County, Colorado, a duly organized county and political subdivision of the State of Colorado ("County"), whose address is 200 South Cascade Avenue, Colorado Springs, Colorado 80903, and the City of Colorado Springs, Colorado, a home rule city and Colorado municipal corporation ("City"), having an address at 30 South Nevada, Ste 401, Colorado Springs, Colorado 80903. The City and the County may be referred to collectively as "Parties" or individually as "Party."

## **RECITALS**

WHEREAS, pursuant to C.R.S. §§ 30-11-101(1), 30-11-103, and 30-11-107(1), the County has the legislative authority to make all contracts and settle all accounts of the County and to exercise such other and further powers as are conferred by law; and

WHEREAS, the City, as a home rule municipality, is a political subdivision of the State of Colorado and likewise has similar powers pursuant to Article XX of the Colorado Constitution, municipal home rule powers, City Charter ordinance provisions, and applicable state statutes of the Colorado Revised Statues; and

WHEREAS, the City and County each wish to identify road segments within their jurisdiction for which the other Party will perform snow removal and snow and ice control responsibilities; and

WHEREAS, the Parties agree it would be of benefit to both Parties to exchange such responsibilities for those road segments listed in Exhibit A.

#### AGREEMENT

**NOW THEREFORE,** in consideration of the foregoing recitals and the terms and conditions set forth below, the sufficiency of which are hereby acknowledged, the Parties agree as follows:

- <u>City and County Responsibilities.</u> The City and County shall each provide snow removal and snow and ice control for those road segments in the other's jurisdiction identified in **Exhibit A**, attached hereto and incorporated herein by reference. No later than July 31 of 2023 and each subsequent year this Agreement remains in effect, Public Works staff from each Party shall meet to review and update **Exhibit A**, and an updated **Exhibit A** shall take effect each year upon signature of the Director of each Party's Public Works Department.
- 2. <u>Term and Termination</u>. This term of this Agreement shall begin on the Effective Date and continue until September 1, 2032, or until such time as either Party terminates the Agreement upon thirty (30) days written notice, whichever is sooner.

- 3. <u>Rights and Remedies Not Waived</u>. No assent, express or implied, by either Party to any breach of this Agreement by the other Party shall be held to be a waiver by such nonbreaching Party of any later breach by the other Party. Neither the County nor the City shall be excused from complying with any provision of this Agreement because of any failure to insist upon, or to seek compliance with, such provision.
- 4. <u>Amendment.</u> This Agreement may only be amended in writing with consent of both Parties.
- 5. <u>Assignment.</u> Neither Party may assign its respective rights and obligations under this Agreement without the written consent of the other Party.
- 6. <u>Applicable Law, Jurisdiction, and Venue.</u> This Agreement is subject to and shall be interpreted under the laws of the state of Colorado, the City Charter, City Code, ordinances, rules and regulations of the City of Colorado Springs, Colorado, applicable regulations of El Paso County, Colorado, and applicable federal law. Court jurisdiction and venue shall be exclusively in the District Court for El Paso County, Colorado.
- 7. <u>No Third-Party Beneficiaries.</u> It is expressly understood and agreed that enforcement of the terms and conditions of this Agreement, and all rights of acting relating to such enforcement, shall be strictly reserved to the Parties. Nothing in this Agreement is intended to create or grant to any third party or person any right or claim for damages or the right to bring or maintain any action at law, nor does any Party waive its immunities at law, including immunity granted under the Colorado Governmental Immunity Act C.R.S. § 24-10-101, et seq.
- 8. <u>Limitations on Jurisdiction</u>. Nothing herein shall be construed so as to in any manner expand upon or limit the lawful jurisdiction and authority of either the City or the County.
- 9. <u>Entire Agreement.</u> This Agreement together with all Exhibits attached hereto, which are incorporated herein by this reference, is intended as the complete integration of the understanding between the parties and constitutes the entire Agreement between the Parties.
- 10. <u>Parties Bound by Agreement.</u> This Agreement is binding upon the Parties hereto and upon their respective legal representatives, successors, and assigns. The undersigned representatives hereby affirm that they have the authority to sign this Agreement and to bind their respective Parties thereto.
- 11. <u>Captions.</u> All captions and headings contained in this Agreement are for convenience only and for reference, do not define or limit the scope or intent of any provisions of this Agreement, and shall not be construed to define or limit the terms and provisions hereof.
- 12. <u>Counterparts.</u> This Agreement may be executed in counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.

- 13. <u>Severability</u>. It is understood and agreed by the Parties that if any part, term or provision of this Agreement is held by a court of competent jurisdiction to be illegal or in conflict with any federal laws, or any law of the State of Colorado, the validity of the remaining portions or provisions shall not be affected and the rights and obligations of the Parties shall be construed and enforced as if the Agreement did not contain the particular part, term, or provision determined by the court to be invalid.
- 14. <u>Contacts and Notice</u>. The County and the City will each provide a liaison through their respective entities and will be responsible for coordinating respective activities under this Agreement. Except as may otherwise be provided in this Agreement, all notices required or permitted to be given under this Agreement shall be in writing and shall be valid and sufficient if dispatched by: (a) registered or certified mail, return receipt requested, postage prepaid, in any post office in the United States, (b) hand delivery, (c) overnight courier, (d) email to the below-designated addresses with proof of receipt. The Parties agree that written notices regarding general operational issues may be accomplished through email.

- 15. Indemnification and Liability. The Parties are prohibited by Article XI, Section I of the Constitution of the State of Colorado, and applicable City Charter provisions and Board resolutions, from indemnifying one another. Each party agrees to be responsible for its own liability incurred as a result of its participation in this Agreement. In the event any claim is litigated, each party will be responsible for its own expenses of litigation or other costs associated with enforcing this Agreement. No provision of this Agreement shall be deemed or construed to be a relinquishment or waiver of any kind of the applicable limitations of liability provided to either the County or the City by the Colorado Governmental Immunity Act, C.R.S. § 24-10-101, et seq. and Article XI of the Colorado Constitution, or as otherwise provided by law.
- 16. <u>Fiscal Obligations/Non-Appropriation</u>. This Agreement is expressly made subject to the limitations of the Colorado Constitution and Section 7-60 of the Charter of the City of Colorado Springs. Nothing herein shall constitute, nor be deemed to constitute, the creation of a debt or multi-year fiscal obligation or an obligation of future appropriations by the

County or the City Council of Colorado Springs, contrary to Article X, § 20, Colo. Const., or any other constitutional, statutory, or charter debt limitation. Notwithstanding any other provision of this Agreement, with respect to any financial obligation of the County or the City which may arise under this Agreement in any fiscal year after the year of execution, in the event the budget or other means of appropriation for any such year fails to provide funds in sufficient amounts to discharge such obligation, such failure (i) shall act to terminate this Agreement at such time as the then-existing and available appropriations are depleted, and (ii) neither such failure nor termination shall constitute a default or breach of this Agreement, including any sub-agreement, attachment, schedule, or exhibit thereto, by the County or the City. As used herein, the term "appropriation" shall mean and include the due adoption of an appropriation ordinance or resolution and budget and specifically as to the City, the approval of a Budget Detail Report (Resource Allocations) which contains an allocation of sufficient funds for the performance of fiscal obligations arising under this Agreement.

17. <u>Independent Entities.</u> The Parties are independent governmental entities. No Party shall be subject to the direct supervision and control of the other respective Parties. Neither the Parties nor any agents, employees, or servants of the respective Parties, shall be deemed to be an employee, agent or servant of any other Party to this Agreement.

## RESOLUTION APPROVING INTERGOVERNMENTAL AGREEMENT FOR SNOW REMOVAL AND SNOW AND ICE CONTROL BETWEEN EL PASO COUNTY AND THE CITY OF COLORADO SPRINGS

WHEREAS, pursuant to C.R.S. §§ 30-11-101(1), 30-11-103 and 30-11-107(1), the Board of County Commissioners of El Paso County, Colorado (hereinafter "Board" or "County"), has the authority to make all contracts and to exercise such other and further powers as are conferred by law; and

WHEREAS, C.R.S. § 29-1-203 provides authority for El Paso County to cooperate or contract with other governmental entities to provide any function, service or facility lawfully authorized to each of the cooperating or contracting governmental units, when deemed by the Board to be beneficial to the citizens of El Paso County; and

WHEREAS, the Board and the City of Colorado Springs (collectively "the parties") desire to enter into an Intergovernmental Agreement (hereinafter "IGA") for the purpose of the parties exchanging maintenance on specific roadways for snow removal and ice control as identified in the IGA, attached hereto as Exhibit A; and

WHEREAS, it is necessary that this IGA be approved by the Board in order to effectuate the transaction described herein.

NOW, THEREFORE, BE IT RESOLVED, the Board of County Commissioners hereby approves the Intergovernmental Agreement between the Board of County Commissioners of El Paso County, Colorado and the City of Colorado Springs for the purpose of the parties exchanging maintenance on specific roadways for snow removal and ice control, for the time period commencing on the effective date of the IGA and continuing until September 1, 2032, unless sooner terminated in accordance with the terms of the IGA.

BE IT FURTHER RESOLVED, that the Chair of the Board of County Commissioners, or the Vice Chair, be and is hereby appointed and authorized to execute all reasonable and necessary documents on behalf of the Board in order to complete the transaction described herein.
