As a voting resident of Colorado Springs, a community member for over 40 years, and a Biologist, I am disheartened by the proposed USAFA annexation and development of the area under review. The area is a rich riparian habitat for numerous species to include large and small mammals, waterfowl, songbirds, and the unique plants which provide food/shelter/nesting materials for this diverse group of organisms. Additionally, Monument Creek is the primary water source for wildlife on the Academy, as well as those which live outside its boundaries downstream. With the acceleration in development of Colorado, the habitat of numerous species has been negatively impacted. Across the United States, the land which comprises many military installations has become refuge habitat for many species. This is also the case for wildlife along the front range, particularly within the boundaries of the land owned by the Air Force Academy. However, not all species can survive habitat relocation, so many forms wildlife are not just able to relocate to less developed areas.

As a Biologist, I realize that if this habitat is annexed, that species such as Preble's mouse, prairie dogs,voles, beavers, muskrat, coyote, white tail deer and numerous warblers to name a few, will be negatively impacted. All of these species have specific habitat requirements, and will not be able to survive in an altered form of their niche which is certain to follow development. Additionally, drainage and erosion concerns, related to development will forever alter the landscape both environmentally and aesthetically, and sadly those changes are irreversible.

Furthermore the proposed locations under development and proposed annexation are used regularly as a teaching, and research resource for cadets enrolled in Biology courses at USAFA. With the mission statement of USAFA in mind, I find this action to be contradictory, as it has a direct negative impact of the ability of those charged with its execution, namely to "educate and train" our future leaders.

The **mission** of the United States **Air Force Academy** is to educate, train, and inspire men and women to become leaders of character, motivated to lead the United States Air Force in service to our nation.

Good afternoon,

As an alumni of the US Air Force Academy, the development proposal to annex 183.13 acres from USAFA to the City of Colorado Springs is extremely discouraging. Every time I return to Colorado Springs I see the extensive amount of commercial and residential expansion taking place along the front range and the fact that USAFA is now on Colorado Springs' target list is concerning. President Eisenhower's wife was from Colorado, and as a family they spent much time here enjoying the vast beauty of the front range. President Eisenhower's affection toward Colorado and its rugged beauty is what prompted him to use his political influence to advocate for Colorado Springs to be the home of USAFA. It is this same natural beauty that draws so many visitors to Colorado 60 years later. As is the case with all military bases throughout the country, I believed USAFA to be a federally owned/protected land. I did not think I would see the day when Colorado Springs would put a price tag on USAFA's invaluable natural preserve, and rather than enjoy its natural state, would look to exploit it.

USAFA is home to a wide array of beautiful native species, to include the Preble's Meadow jumping mouse which is endemic to southern Wyoming and the front range of Colorado to include USAFA. This mouse is listed under the US Endangered Species Act and their habitat directly overlaps with the city's USAFA development proposal. I am not saying that mice are more important that humans, but I don't think this development and fattening the wallets of a few individuals is worth the protected mice's habitat destruction. I was fortunate to conduct field research as a cadet and I spent a lot of time out in the forests throughout USAFA, including the one targeted for development near the North Gate. This is a valuable field location allowing cadets to gather data, think critically, and expand their scientific reasoning. It would be a real shame to develop this area and degrade future cadet's research opportunities. I remember my time collecting data on USAFA fondly, and it was those moments that inspired me to continue my passion for research and to pursue higher levels of education in the field of biology. I would like future cadets to have that same, unhindered opportunity.

Lastly, USAFA is an "open base" with approximately 1 million visitors annually. This requires heightened levels of security to ensure the safety of our cadets as well as their guests. I worry that allowing for additional, civilian development would further compromise the safety of the military installation. A risk no base commander would ever accept.

I hope you will consider the negative ramifications of this development proposal rather than merely the price tag associated with this acreage. I am unable to attend the 17 Jan public meeting but I hope this email will serve to express my voice in opposition to the development proposal on USAFA.

I am a 2004 USAFA graduate and former Assistant Professor in the USAFA Department of Biology, and I am deeply concerned by the proposed annexation of USAFA property to the city of Colorado Springs for development of a new Visitor Center. I am aware that the city would like to showcase the USAFA and other important local activities, but that should *not* justify encroachment on protected lands, critical watershed corridors, or endangered species habitat. The US Air Force Academy property in question along Monument Creek fits all of the above descriptions.

This section of the property (and downstream sites in Monument Creek) provides numerous opportunities for both cadet education and critical ecological research. USFWS personnel and Natural Resource Managers on the installation completed significant riparian restoration work in that same area in response to severe flooding issues after non-porous surface development across I-25 from the North Gate area. USFWS personnel have repeatedly presented significant concerns to the USAFA leadership regarding development of these surface types in close proximity to Monument Creek, both on and off installation, due to the previous damage to this critical riparian corridor (USAFA Natural Resources, 2013).

I recall from my own graduate work that it is not permissible under the Endangered Species Act to develop habitat where endangered species may reside. Can you tell me if the proposed acreage has been properly surveyed for Prebles Meadow Jumping Mouse (PMJM)? Was it determined to be insufficient as PMJM habitat, though it has long been a critical corridor for this species along Monument Creek? Under what authority does the city intend to develop this federallyprotected habitat and adjacent corridor?

Have all requirements under NEPA and NAGPRA been accomplished prior to project execution? Has an Environmental Impact Statement been provided to the City of Colorado Springs for this piece of (at present, still federally-managed) property for the downstream effects in the Monument Creek watershed? Do you have a list of appropriate peer-reviewed scientific literature used to support these documents?

It is my understanding that the development contract has already been awarded to a Blue and Silver Development Partners, LLC, a name clearly associated with a graduate of the institution, though I can find no professional website offering information on the company. It seems that they were one of only two companies to bid for the contract. Some basic Google skills reveal that the responsible party for this brand-new LLC is a 1983 USAFA graduate who actually owns the parent company (Matrix Design Group) that assisted in producing some of the documents for the proposed project. According to his resume available of the Matrix website, he also sits on the USAFA Endowment Board.

The voters and taxpayers of Colorado cherish the natural beauty of their environment and unobstructed views of the mountains above almost all else. I'm not sure developing on or directly adjacent to one of the few habitats remaining for a federally-protected species in Monument Creek is the right call for Colorado Springs.

Mr. Beaudin -

Thank you for the updated email, I have some follow-up information for you for the additional questions you had on the project. Any property own can petition a municipality for annexation if they meet the state statute governing annexation. In this case USAFA is looking to site the projects in the City to follow the City process for development

including access to City utilities. The area identified on the master plan as open space covers a portion over Interstate 25 as well as some steep slope areas, but beyond this if any changes were to be proposed anytime in the future the owner would be required to come back through the City process, involving the citizen comment opportunity, and would have to seek approval of that change with City Council.

There has been an Environmental Assessment done which includes review by the US Fish and Wildlife Services, the Army Corps of Engineers and several other federal departments related to the protection of the Preble's Meadow Jumping Mouse. Along with this all other standard City processes have been followed and information posted out to the community. The initial posting out to the community was on October 29th, 2018 and it is only up until the past week that I have received any public comment. The site was posted, postcards were mailed to all property owners within 1000-foot buffer of the project site and well as all documents were posted to the City website once they were received by the City Planning Department; all of which follows our standard public noticing process.

Thank you for your email in regards to the proposed True North Commons and USAFA Annexation. This project includes applications for annexation of approximately 183 acres with associated zone change, master plan and concept plan establishment. Although the proposed annexation does consist of 183 acres, over 125 of those acres are dedicated per the master plan for open space. The overall developable acres will be just over 57 acres. The United States Airforce is the applicant and property owner for these applications and will ultimately remain the underling property owner.

The United States Airforce Academy petitioned the City for annexation on October 23, 2018. This annexation meets the Colorado State Statute requirements for any annexation being heard before a municipality. Since that time the proposed developer (for the 57 acres) prepared the land use applications required by the City and these have been reviewed by all applicable City agencies. In addition outside agencies including the United States Fish and Wildlife, the Army Corps of Engineers and Colorado Geologic Survey have reviewed the proposed items. All agency comments have been addressed and the proposed applications are moving forward to public hearing.

There will be a robust public hearing process ahead with the first meeting being before City Planning Commission held Thursday January 17, 2019 at 8:30AM at City Hall.

I am writing to request an extension of the comment period and additional public hearings, in non-work hours, regarding the project known as True North Commons involving the USAFA Annexation of 183.13 acres of federal lands to the City of Colorado Springs referencing: CPC A 18-00124; CPC A 18-00125; CPC PUZ 18-00137; CPC PUP 18-00177.

Unfortunately, the announced public comment period and the timing of the public hearing do not allow adequate time for review of the available documents by members of the concerned public, and the hearing time is unlikely to be accessible by anyone who has to work in the daytime, or who is not being paid to attend the meeting as part of their job. This is a large, complex project, involving streets, parking lots, dense use buildings, and interface with natural areas and the Monument Creek area. Review of some of the documentation does not satisfy me that a full environmental impact review has been done, and stream / wetlands issues considered.

As a member of a downstream Fountain Creek community, I have a basis for concern about large, impactful projects on the watershed, including aggravation of run-off pollution and flooding on the Fountain, adequacy of sewage and storm sewer management, and also protection of natural areas essential for the health of the streams involved, including the Fountain Creek and ultimately the Arkansas River.

Thank you for your consideration. I look forward to your response, hoping that there will be additional time for public concerns to be addressed.
