The concerns on the Consideration of the Airport Spectrum Project are:

1) When Milton Proby Pkwy project was constructed the planning for the project was substandard.

The community in the area were told the noise level of the additional traffic would not cause the noise level to increase and would not affect the surrounding neighborhood.

The sound wall which the planners told the neighbors in several community meetings, that the wall constructed would ensure the noise from the traffic would not be noticeable which is not true to this day the sound level of the traffic has been the worse it has ever been.

2) The traffic Melton Proby Pkwy has generated has been a disadvantage to the safety of the public since the law enforcement offices in the Colorado Springs area will not take responsibility of patrolling the road between Powers Blv. and Hancock. Since the road was constructed the speed limits are not obeyed and motorcycles and vehicles speed in this area like it is a drag strip. I have seen construction (dump trucks) trucks hauling rock or dirt to new projects speed in this area; where I have seen on several occasions large dump trucks running the stop light at Milton Proby Pkwy and the Hancock intersection because they were going to fast to be able to stop when the light turns red.

This has been reported to the Traffic Department where no one will answer the phones so messages have been left to report the speeding concerns and the trucks running red lights, however nothing has been done to take care of the problem and no return call are received when asked to be contacted when leaving messages.

By adding additional roads in the area will not help the already existing problem of not providing proper safety for the public.

3) By looking at the projects that have been completed in the area of Milton Proby Pkwy and Powers Blv. shows the lack of proper planning when building in areas that will affect the residents in the area. An example is the ball park which was built off of Powers Blv. near the air port where the lights from the ball field shine into the backyards and houses across from the field.

Planning such as this shows the lack of concern for the people which will be affected by the project, The concern is who is doing the planning and how can we be ensured proper planning will be done.

4)The concern of why the planning department waited until late December to send out the public notice when the proposed annex was accepted on August 22, 2017.

The time frame to get public concerns is an example of how the planning department does not properly plan in order to get good input from the public.

The notice was sent out late December just before Christmas when people are getting ready for the holidays and usually are out of town during the time the cut off for input is requested.
