Disposition of Plans and Other Documents That Had Formally Amended the 2001 Intermodal Transportation Plan

The original 2001 Intermodal Transportation Plan (ITP) was approved by Ordinance 01-158, which will effectively be repealed and replaced by the ordinance adopting ConnectCOS (The Colorado Springs Transportation Master Plan).

During the life of the 2001 ITP, it was formally amended, updated or otherwise augmented by ordinance, a total of eleven (11) times, predominantly during its early years of existence. The draft ordinance that will adopt ConnectCOS, identifies two (2) more recent plans that are proposed to remain in force and effect upon adoption of ConnectCOS. Nine (9) other plans or related documents/amendments are identified by ordinance number in the proposed ordinance as being superseded by ConnectCOS, and therefore will no longer be in force and effect.

The following table summarizes these prior ITP amendments along with their intended disposition and the reasons for this:
