Section 1. That Ordinance No. 22-90 is hereby amended by increasing the Trails, Open Space and Parks Fund expenditure appropriation in the amount of \$7,655,000.00 inclusive of the purchase price, professional services fee, and direct real estate acquisition costs for acquisition of up to 1,021 acres of property known as the Wild Horse Ranch property for the purpose of public open space and trails. The source of funds for the land acquisition is the TOPS fund balance.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
