AND RESOLUTION NO. 78-17 AND ESTABLISHING
MARIJUANA BUSINESS APPLICATION AND LICENSE
FEES AND CHARGES

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF COLORADO SPRINGS, COLORADO**

Section 1. Resolution No. 87-17 correcting a clerical error in Resolution No. 78-17 is hereby rescinded effective February 1, 2025.

Section 2. Resolution No. 78-17 establishing the Medical Marijuana Business Application, License Fees, and Charges is hereby rescinded effective February 1, 2025.

Section 3. The fees and charges as set forth in Exhibit A, attached and made a part of this Resolution, are hereby established for the processing, review, and enforcement of Marijuana Business Application, Licenses Fees and Charges issued by the Office of the City Clerk.

Section 4. These fees and charges shall be effective February 1, 2025, and shall remain effective until amended or rescinded by subsequent Resolution of the City Council.
