ORDINANCE AMENDING ORDINANCE NO. 14-101 (2015 AN APPROPRIATION ORDINANCE) FOR A \$2,000,000 SUPPLEMENTAL APPROPRIATION INCREASING REVENUE AND EXPENDITURE IN THE AIRPORT CAPITAL IMPROVEMENT FUND FOR THE AIRPORT TRENCH DRAIN TERMINAL APRON AND SYSTEM **RECONSTRUCTION PROJECT**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Ordinance No. 14-101 is hereby amended by increasing the revenue and expenditure appropriations of the Airport Capital Improvement Fund in the amount of \$2,000,000 for the purpose of the Airport Terminal Apron and Trench Drain System Reconstruction project. The source of funds is a Federal Aviation Administration grant, a Colorado Department of Transportation grant, and Passenger Facility Charges.

Section 2. This ordinance shall be in full force and effect from and after its final adoption and publication as provided by Charter.

Section 3. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance be available for inspection and acquisition in the office of the City Clerk.
