AN ORDINANCE AUTHORIZING THE AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE CITY OF COLORADO SPRINGS PUBLIC FACILITIES AUTHORITY CHANGING THE COMPOSITION OF THE BOARD OF DIRECTORS AND THEIR TERM OF OFFICE, APPROVING THE EXECUTION AND FILING WITH THE SECRETARY OF STATE OF THE STATE OF COLORADO OF THE ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION, AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE

WHEREAS, the City of Colorado Springs Recreation Authority was formed by Articles of Incorporation filed with the Colorado Secretary of State on February 14, 1989; and

WHEREAS, the Articles of Incorporation have been amended, on July 13, 2000, to change the name to the City of Colorado Springs Public Facilities Authority; and

WHEREAS, in November 2010, the voters in the City of Colorado Springs voted to change the form of government from a Council-Manager form of government to a Council-Mayor form of government; and

WHEREAS, the City will no longer have a City Manager to serve on the Board of Directors of the City of Colorado Springs Public Facilities Authority due to the change in form of government and this change necessitates an amendment to the Articles of Incorporation, particularly Article V; and

WHEREAS, the current Board of Directors wishes to amend the Articles of Incorporation, Article V, to have two members appointed by City Council, the Mayor, the Finance Director, and one other member of the Mayor's staff and, in addition, to change the term of service for each member from five (5) years to four (4) years; and

WHEREAS, the certain provisions of the Articles of Incorporation of the City of Colorado Springs Public Facilities Authority may be amended by the affirmative vote of

two-thirds of the members of the Board of Directors and the affirmative vote of a majority of the members of the City Council by ordinance; and

WHEREAS, the Board of Directors have already met to indicate their desire to amend the Articles of Incorporation and they will hold a Board meeting on April 12, 2011, to pass a Resolution in support of the amendment to the Articles of Incorporation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLORADO SPRINGS:

Section 1. That Article V of the Articles of Incorporation for the City of Colorado Springs Public Facilities Authority shall be amended so that the Board of Directors is composed of two members of City Council, the Mayor, the Finance Director, and one other member of the Mayor's staff.

Section 2. That Article V of the Articles of Incorporation for the City of Colorado Springs Public Facilities Authority shall be further amended to change the term of service for each member from five (5) years to four (4) years.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication as provided by Charter.

Section 4. Council deems it appropriate that this ordinance be published by title and summary prepared by the City Clerk and that this ordinance shall be available for inspection and acquisition in the office of the City Clerk.
